A. PLANNING

1. BICYCLE PLAN –

A.1.a. Plan – MTAB approved the Bicycle Plan and the CEQA findings to the Bike Plan EIR; and legislated 45 near-term bicycle projects at the 6/26 public hearing.

A.1.b. EIR – The Planning Commission certified the Bicycle Plan Final EIR, CEQA findings, and planning code amendments at the 6/25 public hearing.

B. FACILITIES

1. BICYCLE PARKING – Staff has surveyed potential bicycle rack installation locations in every supervisorial district and citywide.

2. BICYCLE SHARING – SFMTA and City Carshare will be joined by public bike sharing company Bixi for a demonstration on August 2, 2009 on John F. Kennedy Drive at Conservatory Drive East from 10 a.m. to 5 p.m.

C. SAFETY OUTREACH

1. ANNUAL CITYWIDE BIKE COUNT – Staff is in the process of staffing and organizing the 4th annual citywide bike count to be held in August 2009.

2. BIKE ED PROGRAM OF THE YEAR – The League of American Bicyclists recognized SFMTA's Adult Bike Ed Program as the outstanding North American program for 2008.

3. BIKE TO SCHOOL DAY – Six high schools, four middle schools and elementary schools participated in the inaugural event on 5/28. The Presidio YMCA, SFBC, DPH, SFUSD and the SFMTA School Safety Program collaborated to launch this event.

D. FUNDING

1. GLEN PARK SR2T GRANT APPLICATION – Staff has drafted an application to be submitted to the Metropolitan Transportation Commission (MTC). All SR2T applications will be presented to the BAC on 7/23. Actual due date for applications is 8/12/09.
