MINUTES OF THE October 27, 2005 MEETING

The Committee adopted the Minutes.

ITEMS ON HOLD

8th and Brannan Streets - Parking Meters

DPT recommends a public hearing to consider establishing parking meters, Area 3, 9:00 AM to 7:00 PM, Monday through Saturday, 2-Hour Time Limit) on:

- A. 8th Street, both sides, between Bryant and Brannan Streets;
- B. 8th Street, east side, between Brannan and Townsend Streets; and
- C. Brannan Street, both sides, between 7th and 8th Streets.

PUBLIC COMMENT

Members of the public may address ISCOTT members on matters that are within ISCOTT's purview and are not on today's agenda.

CONSENT CALENDAR

All matters hereunder constitute a consent calendar, are considered to be routine by ISCOTT and will be acted upon by a single vote. There will be no separate discussion of these items unless a member of the Committee or of the public so requests, in which event the matter shall be removed from the Consent Calendar and considered as a separate item.

1. Mississippi St - Various
DPT recommends a public hearing to consider the following change on Mississippi Street, from Cesar Chavez Street to the northern terminus:
 - A. Rescind "4-Hour Parking Time Limit, 7:00 AM to 6:00 PM, Except Sunday" on Mississippi Street, east side, between Cesar Chavez and northern terminus and establish "2-Hour Parking Time Limit, 7:00 AM to 6:00 PM, Except Sunday";
 - B. Establish Perpendicular Parking on Mississippi Street, east side, between Cesar Chavez Street and northern terminus; and
 - C. Establish "Tow-Away No Parking" on Mississippi Street, west side, between Cesar Chavez Street and northern terminus.
2. 17th and Utah Streets - Tow-Away, No Parking
DPT recommends a public hearing to consider establishing "Tow-Away, No Parking 7:00 AM – 9:00 AM Monday thru Friday" on 17th Street, north side, from 25 feet east of Utah Street to 33 feet easterly.
3. Lakewood at Fairfield Way -STOP Signs
DPT recommends installing a STOP sign on Lakewood Way at Fairfield Way, stopping the northbound direction.
4. Grant Avenue, between Vallejo and Filbert Streets - Parking Time Limit
DPT recommends a public hearing to consider extending the parking meter time limits from 1-hour to 2-hours.
5. Irwin Street - Perpendicular Parking
DPT recommends formally establishing perpendicular parking on the Irwin Street, north side, between 7th and 8th Streets.

CONSENT CALENDAR (cont'd)

6. 17th Street and Harrison Street – Red Zone
DPT recommends a public hearing to consider establishing a clearance red zone on 17th Street, south side, from Harrison Street to 22 feet easterly (a 22-foot zone).

7. McCoppin Street, west of Valencia Street to terminus – Tow-Away, No Parking Anytime
DPT recommends a public hearing to consider establishing “Tow-Away, No Parking Anytime’ on McCoppin Street, north side, west of Valencia Street to terminus.

8. McCoppin Street, west of Valencia Street to terminus – Bike Lanes
DPT recommends establishing bike lanes on McCoppin Street, north side, west of Valencia Street to terminus.

2. Flora and Thornton Street and Reddy Street, Thornton Street and Topeka Avenue – STOP signs and Crosswalk

DPT recommends removing the all-way STOP signs and School crosswalk at the intersection of Flora and Thornton Street. DPT also recommends establishing an All-Way STOP at Reddy Street, Thornton Street and Topeka Avenue.

APPROVED.

3. Citywide - White Zone Unattended Vehicle Exceptions

DPT recommends amending the San Francisco Traffic Code Section 38.C to add two exceptions to the types of white zones where vehicles are allowed to be left unattended for five minutes – schools (when the vehicle displays a special disabled person license or placard) and child care centers.

APPROVED.

4. Laguna Honda Boulevard between Portola Drive and Vasquez Avenue -Bicycle Lanes

DPT recommends a public hearing to consider establishing the following changes:

- A. Bike lanes on Laguna Honda Boulevard, both sides, between Portola Drive and Vasquez Avenue;
- B. A left turn bike lane on Laguna Honda Boulevard, southbound, between Ulloa Street and Portola Drive; and
- C. Two 80-foot bus zones, far side, on Laguna Honda Boulevard at Hernandez Avenue, both directions.

APPROVED.

5. Thornton Avenue, Ledyard Street, Vesta Street, Scotia Avenue - Three-ton Truck Restriction

DPT recommends establishing a 3-ton Truck Restriction on Thornton Avenue between Bayshore Boulevard and 3rd Street, Ledyard Street between Silver Avenue and Thornton Avenue, Scotia Avenue between Silver Avenue and Thornton Avenue, and Vesta Street between Thornton Avenue and Williams Avenue.

6. Sacramento Street at Polk Street - Bus Zones
Muni requests a public hearing to consider extending the Bus Zone on Sacramento Street, north side, from 53 feet to 73 feet west of the Polk Street intersection (a 20-foot extension making the Bus Zone 73 feet long- eliminating one Area 3 metered parking space).

APPROVED.

7. Market Street at Clayton Street
DPT recommends establishing “No Right Turn Except Muni” for Market Street, southbound, at Clayton Street.

APPROVED.

8. 1164-1166 Geneva Avenue - Unmetered Motorcycle Parking
DPT recommends a public hearing to consider installing unmetered motorcycle parking in front of 1164-1166 Geneva Avenue (a 27-foot space accommodating 6 unmetered motorcycle spaces). **NOTE: This item has been withdrawn.**
