Project Description

The San Francisco Municipal Transportation Agency (SFMTA) and Synergy Project Management (contractor), will begin utility relocation for the Union Square/Market Street area. This will require relocating all underground utilities from the street to underneath the sidewalks along Stockton Street. Utility Relocation work on Stockton Street will be performed from January 2011 to approximately July 2012.

Here are some facts that you should be aware of:

Work Area: Along Stockton Street from Sutter to Market Streets, including side streets on Sutter, Geary, Post, O'Farrell, Ellis, Market Streets and Maiden Lane. Two traffic lanes on Stockton Street during construction hours will be limited to buses, taxi's and delivery trucks only. Private passenger vehicles will be rerouted through approved DPT traffic reroute plan. Pedestrian traffic lanes will be created for sidewalk disruption. The contractor will maintain pedestrian access to all businesses during business hours. Please expect an increase in noise, dust and traffic as a result of construction.

The Central Subway Project will meet with the Union Square Business Improvement District (BID) on January 6, 2011 to discuss construction issues and concerns. For more info contact Union Square BID at (415) 781-7880.
