We hereby petition the Parking and Traffic Division to perform the necessary surveys, hold public hearings, and recommend to the San Francisco Municipal Transportation Agency that this area be designated as a Residential Permit Parking area.

We understand that if this area is designated by the San Francisco Municipal Transportation Agency, the following parking regulations would become effective:

- Posted time-limited parking during the designated days and hours
- Exemption from posted time limits for residents and businesses whose vehicles display a valid sticker. The annual cost for the sticker is \$96.00. Residents are allowed one sticker per vehicle registered within the designated area, and each business is allowed one sticker.
