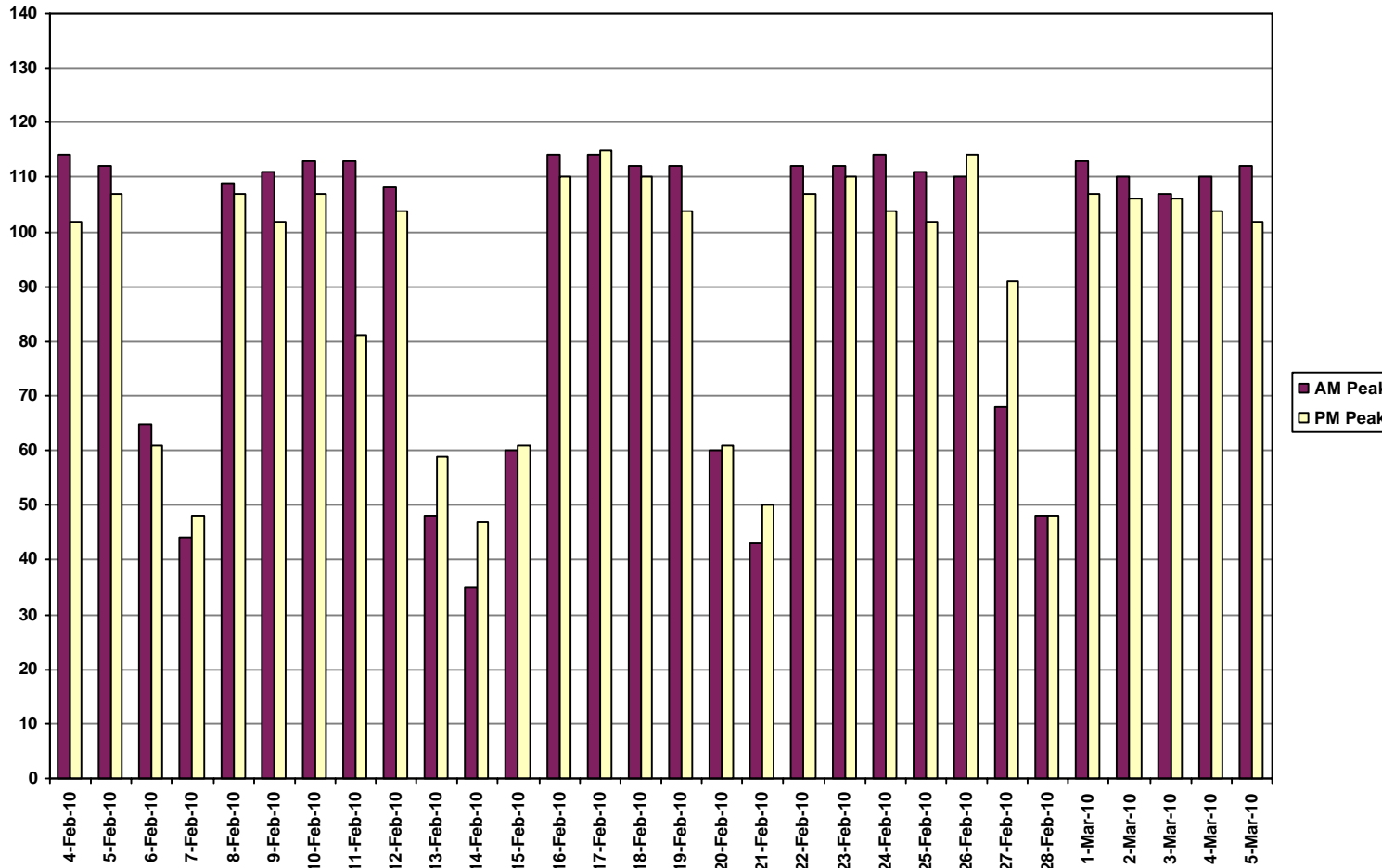

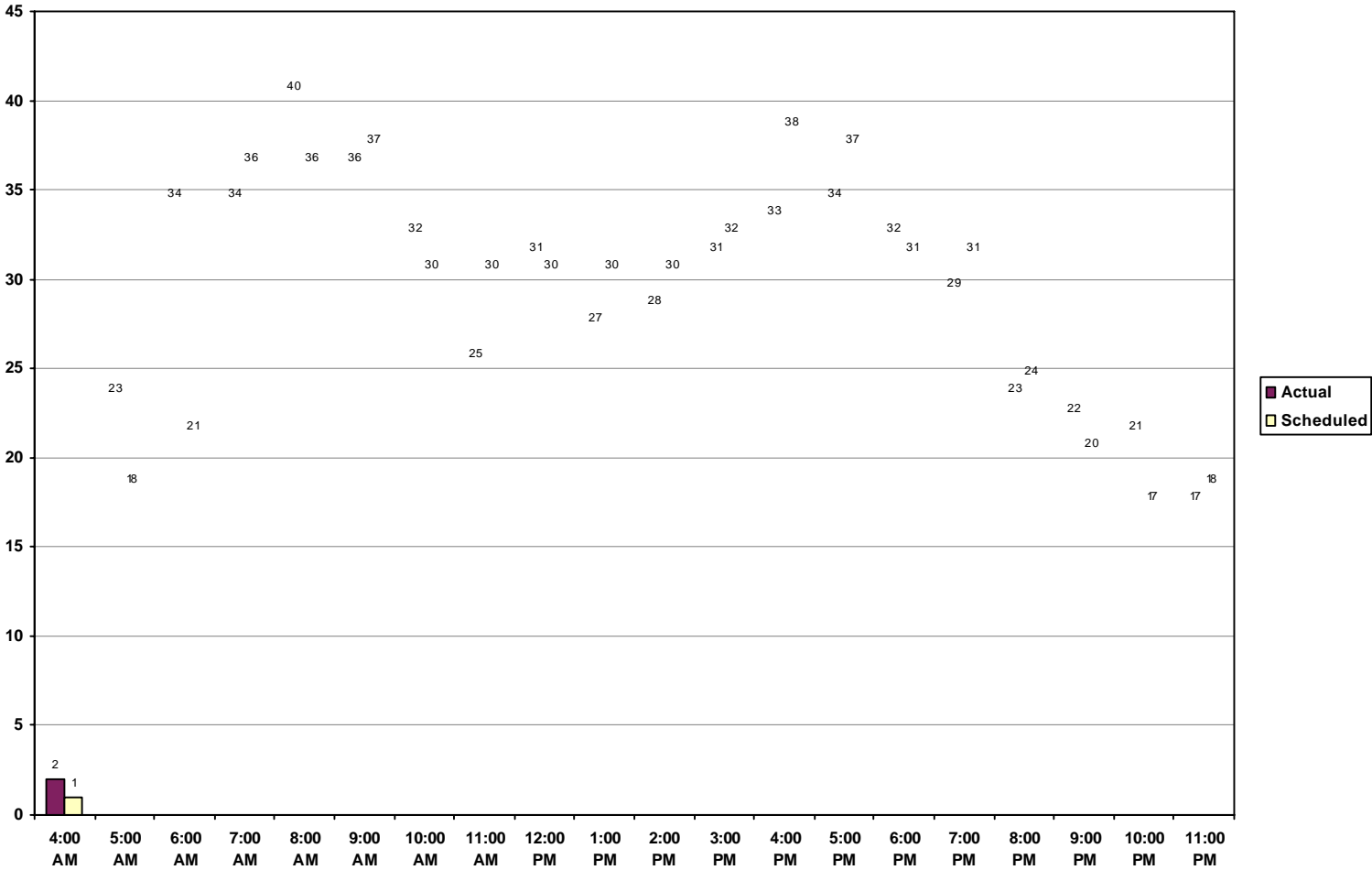

Trains uncoupling on exiting do not count for separate departures at EML.
