Discussion

Glenda Hope stated that #4 –Number of meetings isn't something that the CAC oversees and that the SFMTA should not have to respond to this concern.

Nell Selandar would like to see staff reports prior to meetings as well as background materials 72 hours prior to the meeting. The meetings can be more productive if they don't' require the CAC members to conduct a "study session" of materials during the meeting. What can be done to try to provide staff reports.

BPSACAC NOVEMBER 28, 2017 MINUTES

Robert Muehlbauer would like to see a full day "inter-agency study session" with other "committees" to understand how all of the projects in the neighborhood relate/fit together. The community would be invited so that they can provide input into these projects.

In addition, #4 of the memo should be tabled at this time. It is already hard to maintain a quorum of CAC members.

Public Comment

Frank Markowitz, Manager, SFMTA stated that there are financial constraints to providing "full scale" support for the CAC. The majority of the reports made at the meetings are done by staff from other agencies, which would require SFMTA to "assume" their role to develop staff reports.

Max Ewald asked if someone was taking meeting notes.

Alex Mullaney said that the SFMTA has the funds to provide "full scope" staff support for the CAC and he did the research and said it would be only \$30,000 a year.

Theodore Randolph stated that new housing should be started before transit is finished, then fill I transit deficiencies. More meetings will cover all.

3. Presentation, discussion, and possible action regarding ADA Capital improvement at the northwest corner of San Jose and Geneva. (Kevin Jensen, ADA Coordinator, DPW) (20 minutes)

Discussion

Luis Licea stated that he has seen kids hanging onto the railing next to the ramp and that the "gaps" should be closed to prevent this. IIN addition it would have been nice to see art incorporated into the design of the railing.

Jessie Fernandez asked if there was any one to find out how the ramp is "performing."

Robert Muehlbauer asked Kevin Jensen if he was aware of the NTIP safety study being conducted by Tony Henderson and that it would have been nice to have had community input into the design of the ramp.

Public Comment

Rita, stated that the corner is "programmatic" and that there are not a lot of options for making improvements.

John Winston asked about if there would be an increase in the amount of time a pedestrian would be given to cross the street.

Jason stated that the design requires people to "cut the corner" and that as a design the corner is "not good."

Theodore stated that it would be good to do a road diet at San Jose and I-290 to get the cars to slow down.

Steve Martini asked if there were plans to close off the I-2880 ramp.

Dave, from Sunnyside, stated that he used the ramp in a wheelchair and that it worked.

4. Presentation, discussion, and possible action regarding Balboa Area Transportation Demand Management (TDM) Framework (20 minutes)

Theodore, Excelsior, stated that the TDM is a good idea, car share is needed in the Excelsior, and that existing conditions study becomes obsolete as uses change.

Michael Ahrens, Westwood Park Association expressed concerns about the Framework and read a letter from the Westwood Park Association.

Martha Collins read a resolution from the City College of San Francisco

Jennifer H, Sunnyside, expressed that she accepts the concept of a TDM plan and felt that the ratings on Pages 3 and 4 of the Plan are arbitrary.

John Winston stated that the City College needed a Plan to guide all happening around the school.

David Hooper stated that if parking is diminished at City College cars will then begin to park in his area.

Lisa S., Sunnyside, expressed her concerns about the rating chart in the Framework is subjective and it should be removed. In addition the Executive Summary should have included language that the information provided is a starting point for future discussions.

Allan Ja expressed his concern over the Framework stating that the TDM plan is an excuse to facilitate the Balboa Park Reservoir project, it dumps mitigation responsibilities on to CCSF and the neighborhood.
