Chairman Brinkman called the meeting to order at 1:00 p.m.

2. Roll Call

3. Announcement of prohibition of sound producing devices during the meeting.

Chairman Brinkman announced that the ringing of and use of cell phones, pagers and similar soundproducing electronic devices are prohibited at the meeting. She advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. She also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

4. Approval of Minutes

No public comment.

On motion to approve the minutes of the December 18, 2018 Regular Meeting: unanimously approved (Rubke-absent).

6. Introduction of New or Unfinished Business by Board Members

Director Borden nominated Malcolm Heinicke for the position of Chair.

No public comment.

On motion to elect Malcolm Heinicke as Chair:

Director Brinkman nominated Gwyneth Borden for the position of Vice Chair.

PUBLIC COMMENT:

Melodie expressed hope that Director Borden would do a good job.

Vice Chair Borden requested the meeting be adjourned in memory of Aemon Patrick Joseph Murphy.

Vice Chair Borden requested a report regarding outreach efforts to hire Chariot employees.

Director Torres requested a report regarding the Ford GoBike location in Glen Park.

PUBLIC COMMENT:

Barry Taranto congratulated Chair Heinicke and thanked Director Brinkman. He suggested that staff offer transit jobs to taxi drivers who are going to lose their jobs at the end of the month, similar to how jobs are being offered to Chariot drivers.

7. Director's Report (For discussion only)

-Special Recognition -Update on Vision Zero -Ongoing Activities

Candace Sue, acting Director of Transportation, recognized Janis Yuen, Public Relations Officer, Communications and Marketing.

Tom Maguire, Director, Sustainable Streets updated the Board on Vision Zero efforts including work on Valencia, Townsend and Howard streets. Acting Director Sue noted that Ed Reiskin was in Washington, DC, attending a conference and meeting with congressional leaders. Ms. Sue discussed a

fatality on January 14 at the Van Ness station, the UCSF Mission Bay platform work, elevator repair work; and utility cabinet work in the vicinity of Church and Duboce streets.

PUBLIC COMMENT:

Herbert Weiner complimented the Board on the possibility that Chariot riders may be hired by the SFMTA.

8. Citizens' Advisory Council Report

No report.

9. Public Comment

Marcelo Fonseca discussed taxi medallions. He expressed sympathy for the financial hardships that medallion card holders are going through. The industry can't afford to pay for the mistakes the SFMTA has made. All medallions should be allowed to serve the airport. Director Reiskin's proposals will make it harder for taxi drivers. He urged the Board to reject his proposals as the only way to compete is to achieve a level playing field. No effort has been made in that direction.

Christopher Pederson stated that the SFMTA isn't addressing the severe and chronic issues that Muni faces. It may be facing the same fate as the taxi industry. He waited more than 30 minutes to catch the K line and then the train got held up at many intersections so cars could go through first. Solutions aren't being implemented at near the speed they should be. He urged the Board to swiftly address these problems.

Robert Cesana discussed the debt of the new medallion holders. There was a townhall meeting where a suggestion was made where the SFMTA would pay down the price by \$125,000. If the credit union lawsuit is successful, it will cost the SFMTA approximately \$160 million. Taxi drivers at the meeting seemed willing to accept the offer so this should be pursued.

Mark Gruberg stated that he has been to Sacramento to lobby for the rights of taxi drivers over Transportation Network Companies (TNCs). He suggested relaxing taxi regulations. Taxi regulations must be fair, partial, and evenly regulated which is not happening now. Cab drivers who purchased a medallion need help but this isn't the way. He urged the Board to send the current plan back or starting Feb.1, everyone will pay the price.

Barry Taranto expressed disappointment for losing his job. He can't go to the airport under the new plan. The City is not as busy as was reported by Director Toran. Staff had no proof nor data to show that there is business in the City. This plan is the nail in the coffin for the taxi industry. The changes aren't that major. There will be a shortage of cabs. Customers are starting to come back to taxis.

Charles Rathbone reviewed examples of good processes. He expressed concern about inequities and disparity in the current process. The new airport rules are an example of a poor process. Instead of

consensus, it creates inequity and division. He urged the Board to send the plan back and get a facilitator.

Gordon Wong stated that as a pre-K owner, he is hurting. These rules impact drivers, families, and children.

Carl Macmurdo stated that the airport ban is bad for everyone and will hurt tourism. It's opposed by 85% of the industry, members of the Board of Supervisors and by the credit union. It's clear that the SFMTA has fleeced the credit union. The Schaller report was preordained. Taxi drivers are outnumbered by 30 to 1 by TNCs. He discussed the surrender policy in the Transportation Code. The policy should be changed. There should be a bond measure.

Ben Vallis stated that he is making more money as a TNC driver than he ever made as a taxi driver. It's unfair. All he had to do is download an app and start driving. He suggested charging TNC drivers \$1,000 a year to bail out the medallions.

Ghotra discussed taxi medallions. Taxi drivers are barely surviving as TNCs are taking all the business. The SFMTA should give taxi drivers a break.

Evelyn Poquez stated that the medallion plan will ruin the industry. Many cabs will be banned from going to the airport. This won't bring supply to the city. There are 40,000 TNCs clogging city streets. Taxi drivers won't come to the City. For the convention last week, there were a lot of cabs at the airport but the attendees wanted to take TNCs instead.

Lori Stasukelis discussed the Randall Street bike rack. She asked the Board to put it on hold. The recent approval ignored the Citizens' Advisory Council's (CAC) recommendation that bike rack installations be approved by the SFMTA Board. Nearly everyone opposed the location at Randall and Chenery streets. Dozens sent emails and signed petitions. Motivate had a deceptive campaign. The adjacent school got no notice. A majority of those who were in support don't live in the area.

Christopher Faust discussed the bike share site on Randall. He urged the Board to adopt the CAC's recommendation for bike share sites to be approved by the Board. This is a congested area that's a safety concern. Staff ignored the problems that already exist at the site, including safety issues.

Abdullah Irbaileh discussed his experience as a taxi driver. He expressed support for the proposal for purchased medallions because he has loans to pay. This will be a great opportunity for purchased medallions. It's not complicated.

Ziad Sad stated that he is a medallion buyer. The contract promised that the value of the medallion would be kept at \$250,000. The value has plummeted. There have been no sales for a few years. People invested their life savings and now families are suffering. Everything collapsed when TNCs arrived. Some people lost their houses. The new procedures at the airport are good. The City must act quickly to help.

Yezihlem Joba stated that there is a crisis in the taxi industry. The situation isn't fair. The "K" medallions can help the purchased medallion owners. That would be a better way.

Herbert Weiner stated that he got a rude greeting from the SFMTA this morning when a door slammed on him. This is dangerous and people have died or been injured. The medallion policy has slammed the taxi industry. The cyclists should be charged for licenses. The Board has a double standard. The Board should serve everybody and not play favorites. Holiday service was miserable, especially on the 1 CA line.

Evelyn Engel stated that she is a taxi driver who will be affected by the change. She expects her income to decrease because of the plan even though she mostly drives in the City. Not every taxi driver will be able to drive on a purchased medallion. Cabs are prevented from picking up at several event venues in San Francisco.

Mary McGuire discussed the airport lockout. This will take money out of the pocket of some cab drivers and put it in the pockets of others. Some cab drivers are sleeping outside. The public has also been forgotten. They won't be able to take a cab from the airport at certain times. The public wants to take a large vehicle so their luggage can be accommodated. There's no plan to help taxi drivers to get more revenue in the Schaller plan. There hasn't been a study about assaults on cab drivers.

Mike Spain stated that the Board couldn't revoke permits so it handed the decision to the Director who favored one sector of the industry over the other. The most devalued permits will be purchased. There are fixed costs to operate a cab in San Francisco and the color schemes will have an impossible time finding someone to drive those cabs. This policy has blown a hole in the Clean Air Act.

Peter Miller stated that people who are making money by driving a TNC are being subsidized by the companies. This isn't economically sustainable. The City has chosen to not do anything to help the industry. It has done nothing to regulate TNCs at the airport. The City should refund money to those who purchased a medallion. People are beginning to sleep in their cars. TNCs has been outlawed in various countries. That should happen here.

Frank Fahy stated the taxi regulations have been reinvented at least ten times in the last few years. He discussed the history of the taxi industry. It's been heavily regulated for the safety of the public. TNCs should be regulated to, at least, pay for road repair. The current proposal is eminent domain and is unequal protection.

Chris Sweis conducted a survey on medallion reforms where over half of their income comes from the airport. The industry relies on the airport to make ends meet. 60% of the cabs will be taken off the road with this proposal. These changes are big and are not compromise solutions.

Tariq Mehmood discussed purchased medallions and airport wait times. The entire project is garbage. Malcolm Heinicke shouldn't be on the Board.

David Emmanuel discussed the bike share station location in Glen Park. The neighbors have suggested alternative sites. They don't understand why SFMTA staff hasn't seriously investigated those sites. He wondered about the procedure to evaluate public comment.

Renate Wymiarkiewicz stated that throwing certain medallion holders out of the airport is a waste of time. A thousand cabs are rotating in and out of the airport every three hours. There will never be enough cabs at the airport. This will hurt drivers. The SFMTA should give the money back to the medallion holders who bought them. The medallion sales plan in 2010 was a big mistake. The City tricked people into buying medallions when they knew that TNCs were out there.

Chair Heinicke asked that the survey discussed by Mr. Sweis be conveyed to Director Toran.

Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions</u>: Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
