1. <u>Bridgeview Drive at Topeka Avenue – Red Zone</u> ESTABLISH – RED ZONE

Proposal will add a red zone to improve Muni operations for the 54 Felton outbound.

2. <u>Saint Charles Avenue at Alemany Boulevard – Red Zone</u> ESTABLISH – RED ZONE

This modification will increase turnover and parking availability for visitors to the north entrance of the Potrero Recreation Center Park and Community Garden.

Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors or other City board, commission or department at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision.

Whether the City Traffic Engineer's decision is considered a Final SFMTA Decision is determined by Division II, Section 203 of the Transportation Code. If the City Traffic Engineer approves a parking or traffic modification, this decision is considered a Final SFMTA Decision. If a City Traffic Engineer disapproves a parking or traffic modification and a member of the public requests SFMTA review of that decision, the additional review shall be conducted pursuant to Division II, Section 203 of the Transportation Code. City Traffic Engineer decisions will be posted on <u>https://www.sfmta.com/committees/engineering-public-hearings</u> by 5 p.m. on the Friday following the public hearing. Final SFMTA Decisions involving certain parking or traffic modifications, whether made by the City Traffic Engineer or the SFMTA Board, can be reviewed by the Board of Supervisors pursuant to <u>Ordinance 127-18</u>.
