There is a proliferation of private scooters. There is no culture of safety in this region. Bike routes should not be with Muni routes as it slows down Muni if they're behind a cyclist. He also asked if the scooter companies are paying for the study.

AOCSC Motion 230720.01

The SFMTA CAC recommends that the agency's active communities plan establish a best practice of placing bicycle lanes curbside and protecting them, when concrete curbs are not available, with soft-hit posts spaced closely enough together that motor vehicles cannot drive between them. Additionally, the bicycle lane should be wide enough to accommodate a passing lane.
