BRIEF DESCRIPTION:

Approving providing free Muni transit passes on Clipper® to registered attendees of the Rail~Volution Annual Conference from October 9 - 12, 2016.

SUMMARY:

- San Francisco is the site for the 2016 Rail~Volution Annual Conference, which is expected to attract approximately 1,500 transit professionals and their spouses.
- It is customary for local transit systems to provide a free transit pass to all registered conference participants.
- In September 2000 and June 2008, when the SFMTA hosted APTA's Annual Meeting and Rail Conference, the SFMTA worked with AC Transit, BART, Golden Gate Bridge District, SamTrans, Caltrain, and the Santa Clara County Valley Transportation Authority to provide a transit pass that allowed free rides on these Bay Area transit systems.
- The SFMTA is a sponsor and member of the Rail~Volution 2016 Local Host Committee and is working with Clipper® Card cooperating agencies to provide a transit pass to registered conference attendees to be used on all Bay Area systems from October 9 12, 2016.

PURPOSE

Providing free Muni transit passes on Clipper \mathbb{B} to registered attendees of the Rail~Volution Annual Conference from October 9 – 12, 2016.

GOAL

This recommendation is consistent with the SFMTA Strategic Plan Goal 4: Create a workplace that delivers outstanding service.

DESCRIPTION

Every year Rail~Volution holds a conference for public transportation professionals to engage in educational sessions, workshops, tours, and networking with colleagues. Each year the conference location changes, giving different transit agencies the opportunity to host the conference. The 2016 conference will be held in San Francisco from October 9-12, and it is anticipated that 1,500 transit professionals will attend.

It is customary for local transit systems to provide a free transit pass to all registered conferees. In June 2008, when the SFMTA hosted APTA's 2008 International Rodeo and Rail Conference in San Francisco, the SFMTA worked with AC Transit, BART, Golden Gate Bridge District, SamTrans, Caltrain, and the Santa Clara County Valley Transportation Authority to provide a pass allowing free rides on these Bay Area transit systems. Also, when San Francisco hosted the APTA Annual Meeting in 2000 and 2015, the SFMTA provided a free transit pass to all registered conferees.

This Bay Area coalition is working on the 2016 Rail~Volution conference and will offer attendees a Clipper® Card, which can be used on all Bay Area systems.

STAKEHOLDER ENGAGEMENT

The SFMTA is coordinating with the Clipper® Card Executive Committee and other Local Host Agencies, including BART and MTC, to provide complimentary Clipper® Cards for registered participants at the conference.

ALTERNATIVES CONSIDERED

Not providing the joint transit pass to conference at the Rail~Volution 2016 Conference would be a departure from past practice for the SFMTA and other transit agencies across the nation that host conferences throughout the year such as APTA and Rail~Volution.

FUNDING IMPACT

Providing passes for these events would have minimal impact on fare revenues.

ENVIRONMENTAL REVIEW
