ACCESSIBLE MEETING POLICY

The San Francisco Municipal Transportation Agency Board of Directors/Parking Authority Commission meeting will be held in Room 400, at 1 Dr. Carlton B. Goodlett Place (400 Van Ness Ave.), San Francisco, CA. The closest accessible BART station is the Civic Center Station at United Nations Plaza and Market Street. Accessible Muni transit serving this location are: Muni Metro lines J-Church, K-Ingleside, L Taraval, M Ocean View, N Judah and T Third at Van Ness and Civic Center Stations; F Market-Wharves; 19 Polk, 47 Van Ness; 49 Mission-Van Ness; 5 Fulton; 5R Fulton; 6 Haight-Parnassus, 7 Haight-Noriega 7R Haight-Noriega; 21-Hayes; 9 San Bruno; 9R San Bruno Rapid and 71 Haight-Noriega. The meeting room is wheelchair accessible. Accessible curbside parking spaces have been designated on the Van Ness Avenue and McAllister Street perimeters of City Hall for people with mobility impairments. There is accessible parking available within the underground Civic Center Garage at the corner of McAllister and Polk streets and within the Performing Arts Garage at Grove and Franklin streets.

Chairman Nolan called the meeting to order at 1:00 p.m.

2. Roll Call

3. Announcement of prohibition of sound producing devices during the meeting.

Chairman Nolan announced that the ringing of and use of cell phones, pagers and similar soundproducing electronic devices are prohibited at the meeting. He advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. He also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

4. Approval of Minutes

6. Introduction of New or Unfinished Business by Board Members

Vice Chairman Brinkman requested an update on service animals riding on Muni as well as information regarding street changes being installed by the public.

Director Heinicke arrived.

Ed Reiskin, Director of Transportation, presented an update on Vision Zero projects; Castro Shuttle Service and the N Judah shuttle.

Director Borden arrived.

No public comment.

9. Public Comment

Chris Kitze discussed the naming of the Chinatown Station. Chinatown is one of the real gems of San Francisco and is a real community. He stated that he knows people who were persecuted and had family killed as a result of practicing Falun Gong. Many Chinatown residents fled communism and are thankful to be safe. Chinatown is thankful to have the new subway station but not to name it after Rose Pak who was a representative of communist China. The station should be named after Chinatown.

Tina Ren stated that she does not want the Chinatown Station to be named after Rose Pak. Her family, who practices Falun Gong, were imprisoned or had to leave China. Naming the station after her would be a huge disaster, a shame, and dishonorable.

Michael Niktaris spoke about the naming of the Chinatown Station after Rose Pak. The persecution of Falun Gong has been going on in China for 17 years. It has seeped into American society. Rose Pak assisted the Chinese government in persecuting practitioners in the United States. He urged the Board not to name the station after Rose Pak. San Francisco has been a beacon of tolerance and equality.

Edward Mason discussed various commuter shuttle buses that operate at unauthorized stops in Noe Valley. They impede Muni and traffic. Some buses don't display the correct placards nor license plates. He questioned the integrity and discipline of the commuter shuttle bus program. He has reported issues multiple times that have not been resolved. (Mr. Mason provided a written statement which is included below.)

Genentech and charter service SFO airporter operate at unauthorized stops – 24/Noe and Church/Market. Additional violations include operation on Church St – a residential street, double parking adjacent to a discontinued white zone and impeding Muni and traffic. Genentech and SFO airporter violated the placard agreement. SFO-Airporter violation history include obtaining Placard 06-0002 for display on a vehicle displaying Texas license KO5-4303 that operated in Muni bus zones and on 3 ton restricted neighborhood streets. SFO-Airporter operated Florida registered vehicles 477 and 479 during December 2015 without California license plates and Muni bus zones. The integrity of the corporate commuter bus program is questioned.

Steve Ispas addressed the naming of the Chinatown Station after Rose Pak. He is strongly opposed. He condemns the persecution of Falun Gong and discussed the resolution about Falun Gong at the Board of Supervisors. The language and methods Ms. Pak used against the Falun Gong were the same as the ones used by the Chinese government.

Herbert Weiner stated that the SFMTA goes after parking stops and bus stops and he is disturbed about the termination of bus stops across San Francisco. The latest will be for bus rapid transit on Van Ness. Paratransit isn't the answer but is simply an argument of the SFMTA Board to blow off these concerns. It will create misery. Maybe the answer is to have more buses and to address the internal operation of the SFMTA to focus on late or missing buses. This Board is out of control.

Mari Eliza discussed the red lanes and how they have been expanded. The Mission St. red lanes have been problematic for some time and she wondered when the SFMTA would begin to work with the public.

Mark Gruberg stated that there is a proposal about the sale of taxi medallions that will come to the Board. It will open up medallion sales to anybody who wants to purchase one. The fixed price isn't one that anybody will want to pay. He provided information about current and previous medallion prices in various cities. Taxi trips in New York City are down by about nine percent.

Tom Gilberti stated that taxi drivers need restitution. Twenty-seven years ago there were no wheelchair ramp taxis. A driver will spend two or three minutes to assist a person in a wheelchair when there is no wheelchair lock-up. He wondered why the SFMTA doesn't alternate stops on the L Taraval. The bus noise is ridiculous. Chinatown station should be named after Chinatown. Some commuter shuttle buses take ten minutes to load.

Tad Tedesse stated that he has experienced a troubling occurrence that happens between himself and operators who don't let him board with his service animal. His service animal is registered and is sweet. There was a video taken by a passerby regarding an incident of a Muni operator who kicked him off a vehicle because the dog wasn't muzzled. He has complained numerous times. The operator wouldn't let him on even after he showed the dog's service papers. A Muni supervisor told him that he was correct.
