#### SFMTA Language Assistance Plan (LAP) and Public Participation Plan (PPP)



- The LAP and PPP are required by Title VI of the Civil Rights Act of 1964 and FTA requirements.
- These plans outline SFMTA's strategies to best serve and engage Limited English Proficiency (LEP) populations, minority and low-income users, and general transit users across the City.



## **SFMTA LAP and PPP Updates**

- The goal of the LAP and PPP updates are to keep SFMTA's communication and engagement strategies current and reflective of changing populations and user needs.
- As part of this update, SFMTA is conducting outreach to communitybased organizations (CBOs) that serve and represent these populations and soliciting stakeholder input through interviews, focus groups, and surveys.
- To support this effort, CSA City Performance conducted a solicitation process to secure and manage a contractor.
- Barbary Coast Consulting was selected as the prime, with a team of sub-consultants: FM3, InterEthnica, and JBR Partners.
- The project kicked off February 2016 and will end September 2016.
