- Categorically exempt from Environmental Review Class 1(c)(9) changes in the traffic and parking regulations where such changes do not establish a higher speed limit or result in more than a negligible increase in the use of the street and/or Class 1(c)(13) installation, modification and replacement of traffic signals, where no more than a negligible increase in the use of the street will result.

- B. RESCIND NO PARKING ANYTIME Alemany Boulevard, east side, from Naglee Avenue to 100 feet southerly. PH 5/31/13 Requested by SFMTA.
- C. ESTABLISH TOW-AWAY NO PARKING ANYTIME Alemany Boulevard, east side. from Naglee Avenue to 50 feet southerly. PH 5/31/13 Requested by SFMTA.

- H. ESTABLISH TALL VEHICLE RESTRICTION Geary Boulevard, south side, between the east and west crosswalks at the intersection of Geary Boulevard and Palm Avenue (Parking meters #3541 and #3543). PH 5/31/13 Requested by SFMTA.
- I. ESTABLISH TOW-AWAY NO STOPPING ANYTIME Forest View Drive, west side, from Sloat Boulevard to 20 feet southerly (5-foot wide sidewalk bulb removes one parking spaced); Sloat Boulevard, north side, from Vale Avenue to 76.5 feet easterly (7-foot bus bulb to replace existing bus zone); Sloat Boulevard, south side, from Forest View Drive to 42 feet easterly (7-foot wide sidewalk bulb removes two parking spaces and constructed in conjunction with the installation of two beacon controller boxes); and Sloat Boulevard, south side, from Forest View Drive to 63 feet westerly (7-foot wide bulb to replace existing bus zone).

WHEREAS, The San Francisco Municipal Transportation Agency has received a request, or identified a need for traffic modifications as follows:

- A. ESTABLISH BLUE ZONE 456 Dolores Street, west side, from 139 feet to 161 feet north of 18th Street crosswalk.
- B. RESCIND NO PARKING ANYTIME Alemany Boulevard, east side, from Naglee Avenue to 100 feet southerly.
- C. ESTABLISH TOW-AWAY NO PARKING ANYTIME Alemany Boulevard, east side, from Naglee Avenue to 50 feet southerly.
- D. ESTABLISH TOW-AWAY NO PARKING ANYTIME Bluxome Street, north side, from 5th Street to 25 feet easterly.
- E. ESTABLISH NEW TRAFFIC SIGNAL John Muir Drive and Lake Merced Boulevard Intersection.
- F. ESTABLISH NO U-TURN RESTRICTIONS Southbound Lake Merced Boulevard and eastbound John Muir Drive approaches.
- G. ESTABLISH CLOSING FREE RIGHT TURN Eastbound John Muir Drive to Southbound Lake Merced Boulevard.
- H. ESTABLISH TALL VEHICLE RESTRICTION Geary Boulevard, south side, between the east and west crosswalks at the intersection of Geary Boulevard and Palm Avenue.
- I. ESTABLISH TOW-AWAY NO STOPPING ANYTIME Forest View Drive, west side, from Sloat Boulevard to 20 feet southerly; Sloat Boulevard, north side, from Vale Avenue to 76.5 feet easterly; Sloat Boulevard, south side, from Forest View Drive to 42 feet easterly; and Sloat Boulevard, south side, from Forest View Drive to 63 feet westerly.
- J. INSTALL PEDESTRIAN CROSSING BEACON West crosswalk crossing Sloat Boulevard at Forest View Drive.

WHEREAS, These items are categorically exempt from Environmental Review Class 1(c)(9) changes in traffic and parking regulations where such changes do not establish a higher speed limit or result in more than a negligible increase in the use of the street and/or Class 1(c)(13) installation, modification and replacement of traffic signals, where no more than a negligible increase in the use of the street will result; and,

WHEREAS, The public has been notified about the proposed modifications and has been given the opportunity to comment on those modifications through the public hearing process; now, therefore, be it

RESOLVED, That the San Francisco Municipal Transportation Agency Board of Directors, upon recommendation of the Director of Transportation and the Director of the Sustainable Streets Division does hereby approve the changes.
