

Dogpatch Parking Management

PROJECT OVERVIEW



The Dogpatch is a small neighborhood with major destinations, such as the 22nd Street Caltrain Station, the Muni's T-Third Line along 3rd Street, the 22nd and 3rd Street commercial corridors, the Muni bus maintenance yards and the American Industrial Center, which attract thousands of workers, commuters and visitors.

The Dogpatch Parking Management Plan is an effort to improve the availability of on-street parking to meet this growing demand.

With more development and commerce in the area, parking spots are already scarce during the day and bigger developments are on the horizon. As activity in the Dogpatch grows, on-street parking regulations must be updated to help ensure that parking can be made available for those who need them most. When parking spaces are left unregulated, they tend to stay occupied, which leaves drivers spending more time looking for a spot. That adds to traffic congestion and transit delays, and it makes streets less safe and pleasant for people who live in, work in and visit the neighborhood.

A Dynamic, Growing Neighborhood

- Currently, there are approximately 1,500 housing units in the Dogpatch.
- There are 400 business establishments with 7,000 workers in the Dogpatch.
- More than 2,600 on-street parking spaces (80% of which are unregulated) in the Dogpatch are nearly 100 percent occupied on weekdays. Parking will only get worse if action is not taken to manage it.
- The City Planning Department estimates that over 1,500 new residential units will be built in Dogpatch in the next two years, doubling the total population.
- The Pier 70 project will add as many as 3,000 housing units and 9,800 jobs.
