1. Call to Order

Chairman Zepeda appointed Council member Downey pro tem committee member in order to establish a quorum.

3. Announcement of prohibition of sound producing devices during the meeting

CAC Secretary Robinson-Luqman made the announcement.

4. Approval of Minutes:

5. Report of the Chairman (For discussion only)

Chairman Zepeda wished everyone present a happy new year.

6. Public Comment:

Edward Mason stated that at 22nd and Church streets, there is a lubricator installed with a solar reflector and a large box hanging on a utility pole. It's been almost two years and there are still asphalt temporary patches at this site. At 24th and Church streets, there is a rail slapping issue. Rail slapping is when vehicles go perpendicular to the tracks which causes the track to separate.

7. Presentation, discussion, and possible action regarding bunching, gaps, and delays. (Alex Demisch, Senior Planner, Transit Performance & Analysis. Explanatory documents include a slide presentation.)

Alex Demisch updated the committee on how the SFMTA manages service, measures performance, and gave an overview of next steps in transportation management.

PUBLIC COMMENT:

Edward Mason stated that he hopes service improves. The J Church has been a train wreck for the last nine months or more. The frustration level on the J line is extreme when three J line trains arrive one after the other after 30 minutes of waiting. When there is a delay in the morning, people opt to take an Uber. He stated that he is willing to stick with Muni instead of going with the TNCs but the frustration is growing. He often opts to walk rather than wait.

8. Presentation, discussion, and possible action regarding pedicabs. (Kate Toran, Director, Taxis & Accessible Services. No explanatory documents.)

Kate Toran stated that this is a preliminary conversation. Currently, pedicabs are mostly seen at the port and in Golden Gate Park. They are currently regulated under different jurisdictions throughout the city. The SFMTA plans to get more of an understanding of the various players and see if it makes sense to get a pedicab permit program started. Once the SFMTA private transportation vehicle (PTV) permit program is finalized, staff will circle back to the pedicab permit issue.
