<u>How do I use my card?</u> You must tag your Clipper card to the card reader each time you board a vehicle or enter a station faregate. Tagging your Clipper card will serve as proof of payment electronically confirming that you have a valid fare.

<u>Must I be a San Francisco resident?</u> Yes. The Free Muni Program is only available for San Francisco residents.

Do I need to reapply each month to qualify for the program? No. Once you are deemed eligible for the program you will be enrolled for the entire duration of the pilot, or until the day of your 19th birthday, whichever comes first.

<u>What happens if I lose my card?</u> Contact Clipper Customer Service at 1.877.878.8883 or visit the Clipper in-person Customer Service Center at the Embarcadero BART/Muni Station or the Bay Crossings Customer Service Center at the Ferry Building to apply for a replacement. Please note it may take up to 10 days to process your replacement pass and a \$5 fee will be assessed.

What if I do not have any of the required documents to obtain a Clipper card? Contact your school administrator or call 311 for assistance.

<u>My child is not five yet. When should I apply?</u> Muni service is free for all children under five. Please submit your application for the program within four weeks of your child's fifth birthday.

How long will it take for my application to be processed? Please allow up to three weeks to process applications for existing Clipper card holders and up to five weeks for if a new card is needed.

If your application is accepted, your last transit citation issued within 30 days of enrollment is eligible for dismissal. Please provide a citation or ID number from the citation so that we may review your record.
