Chair Ballard introduced the new SFMTA Board Secretary, Christine Silva.

6. Public Comment:

Edward Mason stated that Daly City BART still lacks bus stop signage for the 14R and the 57 lines. All the other bus bays there are marked for SamTrans while the Muni bus stop is a faded yellow bar on the pavement. Mr. Mason stated that during a northbound trip on the 49 line, the Operator announced that Market Street stop was coming up. The bus stopped in a clearly marked, designated area between Market and Mission. Once the bus crossed Market Street, there were no ambassadors and at least a dozen people trying to wave the bus down. Ambassadors should be strategically deployed at these types of locations when changes happen.

Monica Munowitch, Shared Spaces Deputy Program Manager, presented the item.

PUBLIC COMMENT:

Chaz Hurwitz stated that it is troubling that residents in commercial corridors are never brought up as stakeholders. There needs to be public input. He stated that he lives above and adjacent to a very large parklet that is a restaurant now. Disturbances of noise, trash, and staggering drunk people is a reality for families living in places like Valencia Street. During the pandemic, he was 100% in favor of it. Following the pandemic, he would like some return to normalcy. Residents deserve a say in what their neighborhood becomes.

Martha Bridegam stated that food service and nightlife businesses do need some of this space, but they are not the only ones who need it. Letting someone have a place to sleep without the constant fear of towing or feeling that they are doing something wrong can be a kind of shared space as well. As an employee of a small law office, it would have been great to have space to meet with a client to sign documents during the past year, but they couldn't do that unless one of the neighborhood restaurants happened to be open. Shared Spaces shouldn't just be focused on businesses that serve food and drinks. There are other reasons to share space.

Edward Mason stated that businesses benefit through the tax code. The Board of Supervisors passed the Restaurant and Bar Recovery Act. Senator Weiner supports liquor sales until 4am. Now there is alcohol consumption in public spaces. There's an environmental impact because lighting is being kept on all night to protect the parklets from vandalism. This is a capitalistic system but now the government is intervening and converting public space for private uses.
