Looping in Eddie Tsui from Operations.

Since this would be beyond the scope for Traffic Routing, if they want to expand the permit parking for SFPD at the Taraval Station then they would need to go through Operations. Bryant Woo worked with them in 2020 (email attached) and it's now in the transportation code listed as 166 feet of SFPD permit parking. We cannot expand without going through the legislation process. We would at this time put in the 19 spaces instead of the 20 spaces to give them wider stalls per first request. The other two request would need to be evaluated by Operations and then taken to legislation. This is a balance between neighborhood parking and SFPD permit parking. Not sure how it would be received by the community reserving so many spaces for SFPD Parking on street.

I am the traffic engineer for the project that recently micro surfaced 24<sup>th</sup> Ave between Taraval & Santiago. My understanding is that there is a request to widen the existing parking stalls. Currently, the existing stalls are 8'4". We can widen the stalls 5 more inches; however, by doing so it will remove 1 parking stall. It is my understanding that this permit parking was recently added to the transportation code last year in 2020. Per the transportation code, Division 2 Article 800, the allowable linear feet stated in the code is 166 feet. The previous engineer who worked on these parking stalls, Bryant Woo, was trying to maximize the amount of spaces within the 166 feet. Please advise if you would like to proceed with widening the stalls 5 more inches, 8'9", and you are ok losing one parking stall?

Hello Matthew:

I'll assign Tamam Abdallah of my staff (cc'ed) to repaint the red curb and design marked "SFPD" parking spaces.

Regarding the crosswalk, I already know what DPW and the City Attorney will say. There is a disabled space in front of the station, but you can see that the concrete has been poured to avoid a cross slope in excess of 2% as required by ADA. There is no way to mitigate that same cross slope requirement for a midblock crosswalk on a street that has a 12% grade. DPW would also require curb ramps at both ends of the midblock crosswalk (driveways are non-compliant), and I don't think those are constructible either for the same reasons.

We just finished working with Sgt. DeBernardi on this earlier this year. We had to work with the City Attorney's Office to review and amend the Transportation Code to officially legislate the station's permit parking extension. Is this something new?

Regarding repainting the red zone, I'd prefer to add a couple of signs rather than repaint the red curb because the Crown Vic's are routinely backed into the spaces, hence making it very challenging

to paint the curb. Regarding the midblock crosswalk, that's impossible to paint because the City Attorney has advised us not to mark crosswalks unless there are curb ramps. Given the slope of 24<sup>th</sup> Avenue, it's impossible to construct curb ramps that meet ADA standards.

WHEREAS, The requested expansion along 24th Avenue is for 10 additional parking spaces which requires a 93 foot extension of the existing zone; and,

WHEREAS, SFMTA staff confirmed the need for additional SFPD vehicle parking spaces; and,

WHEREAS, The additional SFPD vehicle only parking spaces allow SFPD vehicles to park adjacent to one another and closer to the station thereby improving access control, security, and emergency response times; and,

WHEREAS, On November 7, 2017, the SFMTA Board approved parking restrictions for SFPD vehicles around Eddy and Jones Streets at the request of the Tenderloin Police Station but the Transportation Code was not amended to reflect this change at the time; and,

WHEREAS, The Transportation Code needs to be updated to reflect both the on-street parking restrictions on 24th Avenue and existing on-street parking restrictions around Eddy and Jones Streets; and,

WHEREAS, The public has been notified about the proposed modifications and has been given the opportunity to comment on these modifications through the public hearing process; and,

WHEREAS, There is no funding impact to the City; and,

WHEREAS, The proposed actions are subject to the California Environmental Quality Act (CEQA). CEQA provides a categorical exemption from environmental review for existing as defined in Title 14 of the California Code of Regulations Section 15301.

WHEREAS, On December 6, 2018, the SFMTA, under authority delegated by the Planning Department, determined (Case Number 2018-017249ENV) that the proposed actions are categorically exempt from CEQA as defined in Title 14 of the California Code of Regulations Section 15301; and,

WHEREAS, The proposed action is the Approval Action as defined by the S. F. Administrative Code Chapter 31; and,

WHEREAS, The proposed action for adopting parking restrictions is the Final SFMTA Decision as defined by Ordinance 127-18; and,
