Director Tumlin shared about Rosa Parks signage, election results, Central Subway Project opening, and an extension to the Shared Spaces application deadline.

Director's Yekutiel requested a report back on the Better Market Street Project.

### PUBLIC COMMENT:

Edward Fisher expressed concern about the lack of street sweeping and accumulating debris because of Shared Spaces.

Dave Alexander commented on parking reform and was excited about parking garage changes in Golden Gate Park.

Herbert Weiner shared that the SFMTA should benefit everyone including seniors and those with disabilities.

Edward Mason expressed concern about access to the Conservatory of Flowers with the closure of JFK Drive.

### 9. Public Comment

Members of the public may address the SFMTA Board of Directors on matters that are within the Board's jurisdiction and are not on today's calendar.

Flo Kelley expressed concern for sidewalk sweeps and asked the SFMTA when tows would be heard at a Board meeting.



Kathy Richter expressed support to restore the 3 Jackson line.

Nancy Mullane reminded the Board of their August 2021 vote to make Lake Street a Slow Street, further reminding their Board of their previous commitment.

Roz Arbel shared about accessibility and safety and expressed support for Slow Lake Street.

Daniela Kirshenbaum shared about the difficulty to get downtown and urged the SFMTA to restore service to pre-pandemic levels.

Kevin expressed concern about transit safety and shared about being assaulted while waiting on a Muni platform.

Aaliyah expressed concern about park closures and parking access.

Herbert Weiner urged the SFMTA to restore service, including the 47 Van Ness and 3 Jackson lines.

David Pilpel thanked staff for recent work on transit shelters as well as a Nextbus system upgrade and expressed support for full transit service restoration.

Speaker asked the Board to restore the 2 Clement and 1AX/1BX California lines to get downtown and to consider reopening Lake Street.

Susan Cieutat asked when the Board would have a hearing about tows.

Barry Taranto expressed concern over taxi access in Golden Gate Park and at the Chase Center, sharing that access is very difficult.

Linda urged the SFMTA to remove barriers on Lake Street and shared that there should be better ways to get around.

Speaker expressed support for Slow Lake Street.

Robert Cesani expressed concern about taxi medallions and SFMTA's management of medallions.

Richard Parena expressed concern about safety and shared about recent experiences getting mugged and assaulted.



Jordan Smith submitted a public records request for records related to a tow he experienced.

David Pilpel agreed with the presentation and shared about previously serving with Director Hinze on the Sunshine Ordinance Task Force.

12. Presentation and discussion regarding a Muni Service Plan Update. (Explanatory documents include a slide presentation.)

Julie Kirschbaum, Director of Transit, presented the item.

### PUBLIC COMMENT:

Jaime Viloria expressed concern about service restoration and suggested that the SFMTA use community liaisons for project-based outreach.

Speaker asked about hiring more security suggesting that fare inspectors double up as security.

Peter Strauss appreciated the presentation and expressed concern about service levels and restoration.

Herbert Weiner was opposed to bond measures and expressed concern about transit and tradeoffs.

David Pilpel expressed concern about rail service beyond the Embarcadero, sharing that forced transfers at 4<sup>th</sup> and King are problematic, and suggested various service changes.

13. Presentation and discussion regarding a Vision Zero Quarterly Update. (Explanatory documents include a slide presentation.)

Tom Maguire, Director of Streets, introduced Uyen Ngo, SFMTA Livable Streets, Acting Vision Zero Program Manager, Thalia Leng, SFMTA Livable Streets, Senior Planner, and Devan Morris, Dept. of Public Health, Integrated Business Systems Analyst, presented the item.

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code



Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

Board of Supervisors review of certain SFMTA Decisions: Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
