Paula Katz submitted the following public comment summary per Administrative Code Section 67.16:

Under Strategy 4, staff will bring you action items to expand paid parking to Sundays and evenings, increase all parking meter fees, and remove all free parking in San Francisco, including forcing all residential neighborhoods into the Residential Parking Permit system, increasing those fees, and on p. 31, charging visitors, including families and friends, to pay to park when they visit us, which would make us a laughing stock throughout the world. It's not clear how these new residential parking fees will reduce climate emissions, versus just being a new tax to fund Muni, or why homeowners, who already pay property taxes, should have to pay this extra fee in neighborhoods that don't want the program. Before staff presents these policies to the Board, it should do extensive outreach, education, and surveys, and work with District Supervisors to hold joint town halls in their districts on these extensive changes.

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions:</u> Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
