BRIEF DESCRIPTION:

Authorizing the Director of Transportation to: (1) execute Bilateral Contract Modification No. 147 to Contract No. 1300, Third Street Light Rail Program Phase 2 - Central Subway Stations, Surface, Track and Systems (Contract) with Tutor Perini Corporation, which resolves and releases all change orders, claims and credits, increases the Contract Amount \$46,755,993.20 for a total Contract Amount of \$1,204,997,857.90, and extends Project Final Completion date 121 days to March 31, 2023; and, (2) accept the Work and close-out Contract 1300 when Contractor has met all Contract requirements for Final Acceptance.

SUMMARY

- In May 2013, the SFMTA contracted with Tutor Perini Corporation (Contractor) to construct the Central Subway Stations, Surface, Trackway and Systems under SFMTA Contract No. 1300 for a Contract Amount of \$839,676,400, all work to be completed in 1700 days, with Final Completion date May 11, 2018. The Contract has been amended 146 times to increase the Contract Amount by \$318,565,464 to \$1,158,241,864.70 (a 38 percent increase) and extend Contract Time 1,754 days to compensate Contractor for over 2,500 change orders and to resolve Contractor claims arising from unforeseen site conditions and design changes.
- Contract Modification 147 (Amendment) increases the Contract Amount \$46,755,993.20 (net), which includes \$39,359,659 to compensate the Contractor for additional work performed under 377 Change Orders, \$7.7 million to resolve a lawsuit by Contractor to recover COVID-19 pandemic inefficiency costs, and \$3,246,041 in late payment interest, and reduces the Contract Amount of \$2,144,299 from unused contingency funds and \$700,000 for corrective work that the SFMTA will have others perform, and other credits Contractor owes the SFMTA. This Amendment extends the Final Completion Date to March 31, 2023, and Contractor waives all claims known and unknown arising under the Contract.

PURPOSE

Authorizing the Director of Transportation to: (1) execute Bilateral Contract Modification No. 147 to Contract No. 1300, Third Street Light Rail Program Phase 2 - Central Subway Stations, Surface, Track and Systems (Contract) with Tutor Perini Corporation, which resolves and releases all change orders, claims and credits, increases the Contract Amount \$46,755,993.20 for a total Contract Amount of \$1,204,997,857.90, and extends Project Final Completion date 121 days to March 31, 2023; and, (2) accept the Work and close-out Contract 1300 when Contractor has met all Contract requirements for Final Acceptance.

STRATEGIC GOALS AND TRANSIT FIRST POLICY PRINCIPLES

This item will support the following SFMTA Strategic Plan Goals and Objectives:

- Goal 4: Make streets safer for everyone.
- Goal 5: Deliver reliable and equitable transportation services.
- Goal 6: Eliminate pollution and greenhouse gas emissions by increasing use of transit, walking, and bicycling.

This item will support the following Transit First Policy Principles:

- 1. Improves the safe and efficient movement of people and goods.
- 2. Improves public transit as an attractive alternative to travel by private automobile.
- 8. Allocates transit investments to meet the demand for public transit generated by new public and private commercial and residential developments.
- 9. Promotes the use of regional mass transit and the continued development of an integrated, reliable, regional public transportation system.

DESCRIPTION

A. Project Background

The SFMTA contracted in May 2013 with Tutor Perini Corporation (Contractor) to construct the Central Subway Stations, Surface, Trackway and Systems under Contract No. 1300, Third Street Light Rail Program Phase 2 - Central Subway Stations, Surface, Track and Systems (Contract) for a total Contract Amount of \$839,676,400 and Contract Time of 1700 days, with a Final Completion date of February 11, 2018.

The Contract has been previously amended 146 times to approve approximately 2,500 Change Orders, to increase the Contract Amount from \$839,676,400 to \$1,158,241,864.70, an increase of \$318,565,464 (38 percent) and extend Contract Time 1,754 days (for a total of 3,454 days) to compensate Contractor and resolve Contractor claims for costs arising from that additional work and Project delays resulting from unforeseen site conditions and design changes.

The SFMTA declared Substantial Completion of Contract 1300 Work with the completion of major systems work on June 28, 2021. The Central Subway commenced Revenue Service (full passenger service) on January 7, 2023.

B. Change in Contract Amount

This Amendment will increase the Contract Amount \$46,755,993.20, which is net of \$50,305,700 increases and \$3,549,706.80 in deductions, resulting in a final total Contract

Amount of \$1,204,997,857.90, which are summarized in the following table and explained in the Sections 1-4, below:

1. Additional Work. Commencing December 21, 2021 (the cutoff date for Change Order disputes and Contractor claims resolved under Contract Modification 143 – Omnibus Claims Resolution No. 3), Contractor performed Work under 377 Change Order Requests (CORs) and Proposed Contract Changes (PCCs) (collectively referenced as "Change Orders"), the negotiated value of those Change Orders is \$39,359,659.00, to compensate Contractor for all costs and impacts of the additional work it performed under those Change Orders, which are listed in Attachment 1 to the Amendment.

2. Interest for Late Payments This Amendment includes \$717,524 to resolve Contractor claims for late payment of approximately \$19.6 million in invoices for work performed from September 2022 to the Effective Date of this Amendment. Invoices were paid late because project staff incorrectly treated the \$10.5 Million unused contingency funds credited to the SFMTA under Contract Modification 144 as funds available to pay Change Orders. This error and other errors in Project accounting and Change Order management caused the City's payment system to hold subsequent payment applications, resulting in late payment of Contractor invoices commencing in September 2022 and continuing to the present. Contractor has asserted it is due 10 percent interest on the unpaid \$19.6 million , as provided in Contract, General Provisions section 9.14, S.F. Administrative Code section 6.22(j)(7), and California Code of Civil Procedure section 685.010(a).

This Amendment also includes \$2,528,517 in interest, as required by Contract Modification 137, in which the SFMTA agreed to pay Contractor six percent interest for late payment of \$28.6 Million (of the \$93.6 Million settlement effected under Contract Modification 137).

3. Settlement of Covid Impacts Lawsuit. This Amendment includes \$7,700,000 as settlement of a lawsuit (Tutor Perini Corp. v. CCSF/SFMTA, Santa Clara County Sup. Ct. Case No. 23CV414035) that Contractor filed against the SFMTA to recover the additional costs Contractor incurred arising from work inefficiencies and related impacts from meeting County Health Orders working requirements during the Covid-19 pandemic. (The settlement of the lawsuit is addressed in a separate SFMTA Board action.)

4. Credits to the SFMTA – Reductions to the Contract Amount

- a. The Contract contains numerous contingency funds (also referenced as "Allowances") that were used to compensate the Contractor for units of materials or work where it was not possible to determine the full extent of the required materials or work at the time of bidding. (The use of contingency funds is a common practice in large construction contracts.) There are \$2,144,299.00 in unused contingency funds remaining in the Contract, which this Amendment deducts from the final Contract Amount.
- b. Contractor owed Thales Transport & Security, Inc., the Advanced Train Control System vendor, \$705,407.80 in retention dating from the period that Thales was a subcontractor to Tutor Perini Corp. Contractor did not remit the funds to Thales as required by Contract 1300. The SFMTA subsequently paid Thales the retention, and in this Amendment deducts that amount from the Contract Amount, as allowed by the Contract, which reduces the Contract Amount \$705,407.80.
- c. The SFMTA has the right under the Contract to contract separately for corrective work where Contractor is unable or unwilling to correct incomplete and nonconforming Work. The Amendment credits the SFMTA the following amounts for incomplete and/or Non-Conforming Work that the SFMTA will have performed by others:
 - (1) \$200,000 to replace defective spool insulators in the Overhead Contact System (OCS) and to compensate the SFMTA its costs for OCS repairs related to spool insulator failures.
 - (2) \$500,000 for grouting of the Chinatown Station (CTS) cavern crown and other locations for where Contractor did not meet Contract requirements to install grouting. The incomplete and nonconforming grout work is allowing water seep into various locations in the Central Subway stations.

C. Change in Contract Time

This Amendment will extend Final Completion date 121 calendar days to March 31, 2023, resulting in total Contract Time of 3,483 calendar days. The additional time was necessary for Contractor to complete 377 Change Orders issued on or after December 21, 2021, the cut-off date for previous claims settlements. (When the SFMTA awarded the Contract in May 2013, the Contract Time to complete all work was 1700 calendar days, with a Final Completion Date of February 11, 2018.)

D. Final Acceptance and Close-out of Contract 1300

The SFMTA Board of Directors' approval of this Amendment will authorize the Director of Transportation to execute this Amendment, and to issue Final Acceptance of the Contract Work and administratively close-out the Contract when Contractor has met all Contract requirements for Final Acceptance. Subcontractors and suppliers have lodged approximately \$312,000 in claims (stop payment notices) against contract funds. The SFMTA will withhold the amounts in controversy from the approximately \$5.3 million retained funds held in escrow until those claims are resolved.

STAKEHOLDER ENGAGEMENT

The SFMTA meets with community organizations and elected officials on a regular basis to inform them of construction activities, the status of the Project, and anticipated completion dates.

ALTERNATIVES CONSIDERED

The SFMTA Board could reject the proposed Bilateral Contract Modification 147, but doing so may result in legal action by the Contractor to obtain the compensation provided in the Amendment, which may result in a less advantageous outcome for the SFMTA. It is unlikely that additional negotiations with the Contractor would produce a better result for the SFMTA.

FUNDING IMPACT

The costs of the Amendment will be funded from: (1) unused bond funds from the Public Transportation Modernization, Improvement, and Service Enhancement Account Program (PTMISEA), authorized by Proposition 1B, the Highway Safety, Traffic Reduction, Air Quality, and Port Security Bond Act of 2006; (2) Reallocated Proposition B funds; and, (3) reallocated 2021 Revenue Bonds.

ENVIRONMENTAL REVIEW

The Central Subway Final Supplemental Environmental Impact Statement / Supplemental Environmental Impact Report (Central Subway SEIS/SEIR) evaluated the environmental impacts of the Central Subway Project, including construction of the subway stations. On August 7, 2008, the San Francisco Planning Commission certified the Final SEIR (Case No. 1996.281E). On August 19, 2008, the SFMTA Board of Directors approved Resolution 08-150 adopting Central Subway Project Alternative 3B as the Locally Preferred Alternative, the California Environmental Quality Act (CEQA) Findings, Statement of Overriding Considerations, and the Mitigation Monitoring and Reporting Plan. The changes to the Project effected by Modification No. 147 to Contract No. 1300, as described herein, fall within the scope of the Central Subway SEIS/SEIR.

The Central Subway SEIS/SEIR is on file with the SFMTA Board of Directors and may be found at <u>Central Subway Final SEIS/SEIR | SFMTA</u>, and 49 South Van Ness Avenue, Suite 1400 in San Francisco, and is incorporated herein by reference.

OTHER APPROVALS RECEIVED OR STILL REQUIRED

The City Attorney's Office has reviewed this calendar item. No other approvals are required.

WHEREAS, Design and construction of the 1.75-mile Central Subway (Central Subway Project) is Phase 2 of the Third Street Light Rail Transit Project; and,

WHEREAS, On May 21, 2013, the SFMTA Board of Directors awarded Contract No. 1300, Third Street Light Rail Program Phase 2 - Central Subway Stations, Surface, Track and Systems (Contract) to Tutor Perini Corporation (Contractor) to construct one street-level and three subway stations, trackways, and systems for the Central Subway Project for a Contract Amount of \$839,343,400 and Contract Time to complete all work within 1700 calendar days, with a Final Completion date of May 11, 2018; and,

WHEREAS, The Contract previously was amended 146 times to increase the Contract Amount to \$1,158,241,864.70 and extend Contract Time 1,754 days to approve 2,500 Change Orders and resolve Contractor claims arising from unforeseen site conditions and design changes; and,

WHEREAS, The SFMTA declared Substantial Completion of the Work following the completion of systems work on June 28, 2021, and the Central Subway commenced Revenue Service (full passenger service) on January 7, 2023; and,

WHEREAS, Bilateral Contract Modification No. 147 (Amendment) is intended to resolve all Contractor claims for additional compensation and extension of Contract Time, and interest on late payments, resolve SFMTA claims for credit and reduction in the Contract Amount for unused contingency funds, Non-Conforming Work, and accounts paid, and authorize the close-out of the Contract; and,

WHEREAS, The Amendment includes the negotiated amount of \$39,359,659 to be paid to the Contractor for completion of Additional Work the Contractor performed under 310 Change Orders listed in Attachment 1 to the Amendment, which resulted from SFMTA and Citydirected design changes, and changes which were required to comply with regulatory agencies' permit requirements; and,

WHEREAS, The Amendment includes \$7,700,000 to be paid Contractor as settlement of Tutor Perini Corp. v. CCSF/SFMTA, Santa Clara County Sup. Ct. Case No. 23CV414035, a lawsuit Contractor filed against the SFMTA to recover additional costs Contractor incurred due to work inefficiencies and related impacts arising from its compliance with San Francisco County Health Orders and work requirements during the Covid-19 pandemic, which settlement is approved in a separate SFMTA Board action; and,

WHEREAS, The Amendment includes \$3,246,041 to be paid to the Contractor to resolve its claims for statutory and contract interest for late payment of undisputed invoices, and payment of interest agreed in Contract Modification 137; and,

WHEREAS, The Amendment reduces the Contract Amount \$2,144,299 by liquidating unexpended funds remaining in Contract contingency accounts, which are listed in Attachment 2 to the Amendment; and,

WHEREAS, The Amendment reduces the Contract Amount of \$700,000 as credit to the SFMTA for the value of corrective work that the SFMTA will have others perform to correct incomplete or Non-Conforming water proofing and grouting at the Chinatown Station, and to replace defective spool insulators in the Overhead Contact System (OCS) and make related repairs to the OCS, which releases Contractor from further obligation to compensate the City the costs of that corrective work, but does not waive or in any way compromise Contractor's contractual or statutory obligations as to warranty and latent defects; and,

WHEREAS, The Amendment reduces the Contract Amount \$705,407.80 to credit the SFMTA that amount, which the SFMTA paid to Thales Transport & Security, Inc., as provided in Contract Modification 93; and,

WHEREAS, The net value of payment due and credit to the SFMTA increase the Contract Amount \$46,755,993.90, for a final Contract Amount of \$1,204,997,857.90, which is the final Contract Amount for purposes of Contract Final Acceptance; and,

WHEREAS, The Amendment extends the Contract Final Completion date 121 calendar days to March 31, 2023 for a total Contract Time of 3,483 calendar days; and,

WHEREAS, The Amendment includes a broad global release by which Contractor releases all claims known and unknown that it may or might bring against the City arising from the Central Subway Project; and,

WHEREAS, The Central Subway Final Supplemental Environmental Impact Statement/Supplemental Environmental Impact Report (Central Subway SEIS/SEIR) evaluated the environmental impacts of the Central Subway Project, including construction of the subway stations; on August 7, 2008, the San Francisco Planning Commission certified the Final SEIR (Case No. 1996.281E); on August 19, 2008, the SFMTA Board of Directors approved Resolution 08-150 adopting Central Subway Project Alternative 3B as the Locally Preferred Alternative, the California Environmental Quality Act (CEQA) Findings, Statement of Overriding Considerations, and the Mitigation Monitoring and Reporting Plan; and,

WHEREAS, The changes effected by the Bilateral Modification No. 147 to Contract No. 1300, as described herein, falls within the scope of the Central Subway SEIS/SEIR; and,

WHEREAS, The Central Subway SEIS/SEIR is on file with the SFMTA Board of Directors and may be found at <u>Central Subway Final SEIS/SEIR | SFMTA</u>, and 49 South Van Ness Avenue, Suite 1400 in San Francisco, and is incorporated herein by reference; now therefore, be it

RESOLVED, That the SFMTA Board of Directors has reviewed and considered the Central Subway Supplemental Environmental Impact Statement/Supplemental Environmental Impact Report and record as a whole, and finds that the Central Subway Supplemental Environmental Impact Statement/Supplemental Environmental Impact Report is adequate for the Board's use as the decision-making body for the actions taken herein relative to construction of the Project, and incorporates the California Environmental Quality Act (CEQA) findings by this reference as though set forth in this Resolution; and be it further

RESOLVED, That the SFMTA Board of Directors authorizes the Director of Transportation to: (1) execute Bilateral Contract Modification No. 147 to Contract No. 1300, Third Street Light Rail Program Phase 2 - Central Subway Stations, Surface, Track and Systems (Contract) with Tutor Perini Corporation, which resolves and releases all change orders, claims and credits, increases the Contract Amount \$46,755,993.20 for a total Contract Amount of \$1,204,997,857.90, and extends Project Final Completion date 121 days to March 31, 2023; and be it further

RESOLVED, That the Director of Transportation shall withhold progress payment retained funds (retention) as legally required and necessary to pay stop notices, prevailing wage actions, and other lawful claims against Contract funds; and be it further

RESOLVED, That the SFMTA Board of Directors authorizes the Director of Transportation to accept the Work from Tutor Perini Corporation, issue final payments, release retention (less amount subject to claims), and close-out Contract 1300, when Contractor has met all Contract requirements for Final Acceptance; and be it further

RESOLVED, That the SFMTA Board authorizes the Director of Transportation, in consultation with the City Attorney, to make such changes to Contract Modification 146 as necessary to effect the intent and purpose of this Resolution, provided that said changes shall not further increase the Contract Amount or further extend Contract Time beyond the values stated in this Resolution, or reduce warranty or bond protections stated in the Contract.

Contract Modification No. 147 – STS: Final Project Acceptance and Closeout – Omnibus Resolution Change Items No. 4

Summary and Purpose:

This Contract Modification 147 ("Amendment"): (1) finally and fully resolves all Contractor's claims for additional compensation and/or time related to SFMTA Contract No. 1300, Third Street Light Rail Program Phase 2 – Central Subway Stations, Surface, Track and Systems (Contract 1300), including but not limited to claims related to Proposed Contract Changes (PCCs), Change Order Requests (CORs), Certified Contract Claims (CCCs), Contractor's claims for COVID-19 impacts and inefficiencies, and contractual and statutory interest for late payment that Contractor has or may assert, and Contractor claims for additional compensation for any and all direct costs, indirect costs, overhead, delay, impacts, inefficiencies and other costs related to or arising from Contract 1300 and Contractor's work on the Central Subway Project, without restriction; (2) adjusts the Contract Amount and Contract Time; and, (3) credits the SFMTA for contingency funds not used, and for the value of corrective work and other credits due the SFMTA as described in this Amendment; and, (3) acknowledges that Contractor has completed all Contract 1300 requirements for Final Completion and Final Acceptance.

Now, therefore, in accordance with the General Provisions of Contract 1300 and the foregoing statements, Contract 1300 is modified as follows:

1. Contract Amount:

a. The SFMTA will pay the Contractor \$39,359,659 to compensate the Contractor for all costs and impacts of every kind, including but not limited to direct costs, indirect costs, delays, inefficiencies, and other time impacts in any way related to or arising from Contractor's performance of Work for the Central Subway Project, including but not limited to Work described in the CORs, PCCs and CCCs (collectively "Change Orders") listed in Attachment 1, which includes all remaining and previously unresolved Change Orders issued under Contract 1300

b. In addition to the amount described in paragraph 1a above, as provided in the negotiated settlement of the lawsuit in Tutor Perini Corp. v. CCSF/SFMTA, Santa Clara County Sup. Ct. Case No. 23CV414035, approved by Contractor and the SFMTA Board of Directors (MTAB Resolution No. ______ dated June 6, 2023), the SFMTA will pay the Contractor \$7,700,000 as settlement of all Contractor claims for direct costs, indirect costs, other costs, inefficiencies, delays and other impacts arising from or related to performing Work during the COVID-19 pandemic. (The SFMTA Board separately approved the negotiated settlement of that lawsuit, and the amount of that settlement is accounted here as part of the Contract Amount.)

c. The SFMTA will also pay the Contractor \$717,524, to compensate for the SFMTA's late payment of invoices from September 2022 through the Effective Date of this Amendment, and

\$2,528,517 for final payment of interest as provided in Contract Modification No. 137, and to resolve finally and fully any claim for interest that Contractor may bring under Contract 1300, General Provisions section 9.14.C, San Francisco Administrative Code section 6.22(j)(7), or California Code of Civil Procedure section 685.010.

d. The SFMTA is credited and the Contract Amount is reduced \$2,144,299 for unused Contract contingency funds listed in Attachment #2 to this Amendment.

e. The SFMTA is credited and the Contract Amount is reduced \$705,407.80 for the SFMTA's payment of retention to Thales Transport & Security, Inc., as discussed in Section 3 of this Amendment.

f. The SFMTA is credited and the Contract Amount is reduced \$200,000, which is compensation to the SFMTA for its costs to replace defective spool insulators and perform related repairs to the Overhead Contact System (OCS), discussed in Section 3 of this Amendment.

g. The SFMTA is credited and the Contract Amount is reduced \$500,000, which is the SFMTA's cost to complete grouting work, discussed in Section 3 of this Amendment.

h. The Total Contract Amount as amended by this Contract Modification 147 is \$1,204,997,857.90. As of the Effective Date of this Amendment, the City has issued payment to Contractor in the amount of \$1,177,342,196.17. The City shall pay Contractor **\$27,655,661.73** as the Final Payment Due, which is the difference between the sum of all Prior Payments and the Total Contract Amount as amended by this Contract Modification 147. The changes to the Contract Amount are summarized in the following table.

2. Contract Time and Final Completion Date

The Final Completion Date is extended to March 31, 2023. Contract Time is increased 121 Days for an amended total Contract Time of 3,483 Days. Any work that Contractor performed March 31, 2023 is Warranty Work or Incidental Work that included in the Contract, and is not Additional Work for which Contractor may claim additional compensation.

3. Changes to the Work

For the reasons described below and in accordance with the referenced provisions of Contract 1300, the SFMTA deletes the following Work from Contract 1300 and shall be credited the value of that Work ,as listed below.

a. Certificate of Occupancy. Contractor represents that it was unable to obtain final Certificates of Occupancy required by the Contract by the date of Final Acceptance. The SFMTA will accept the current Temporary Certificates of Occupancies, and the SFMTA will assume responsibility for obtaining the final Certificates of Occupancy with no change to the Contract Amount. The SFMTA waives the requirement stated in Contract 1300, General Provision section 3.07. i that Contractor provide a final Certificate of Occupancy.

b. Grouting. The SFMTA has determined that grouting at various locations in the Chinatown Station (CTS) is Non-Conforming or otherwise incomplete Work. Contractor disputes that determination. As a compromise to resolve this dispute, the Contract Amount shall be reduced \$500,000 to credit the SFMTA the cost to perform grouting in the CTS. which work the SFMTA will have others perform. The City will not seek and waives further compensation or remedy from Contractor for the grouting work at the CTS that the SFMTA will have others perform. Contractor is responsible for all other grouting Work that it performed at CTS and elsewhere in the Project, which is covered under general and special warranties, as provided in Contract 1300.

c. Overhead Contact System. The SFMTA has determined that spool insulators Contractor installed as part of Overhead Contact System (OCS) are defective and have caused the OCS to fail twice. Contractor has disputed that determination. As a compromise to resolve this dispute, the Contract Amount shall be reduced \$200,000 to credit the SFMTA its costs to replace the defective spool insulators, which the SFMTA will have others perform. The City will not seek and waives further compensation or remedy from Contractor the replacement of the spool insulators. Contractor is responsible for all other OCS Work that it performed, which is covered under general and special warranties, as provided in Contract 1300.

d. Thales Retention. On or about December 20, 2022, the SFMTA paid Thales Transport & Security, Inc. \$705,407.80 to resolve Thales' claim for retained funds held by Contractor, as further described in Contract Modification 93. The Contract Amount is reduced by \$705,407.80 as credit and recompense to the SFMTA for that payment, which fully resolves that payment dispute.

4. Performance Bond

In accordance with Special Provision SP-8, Contractor may reduce the existing performance bond to \$120,490,418, which is ten percent of the final Contract Amount. Said performance bond shall remain in effect until at least June 28, 2026 (which is five years past the agreed Substantial Completion date of June 28, 2021). Said limits of the punitive value and term of the performance bond do not waive or modify Contractor's warranty obligations under

Contract 1300 or Contractor's obligations concerning latent defects in the Work. Contractor's submission of bond certificate showing the reduced limits of the performance bond is not a requirement of Final Completion or Final Acceptance.

5. Final Acceptance

The SFMTA acknowledges that Contractor has met all requirements of Contract 1300 for Final Completion and Final Acceptance of the Work, and is not aware of any claims or causes of action that it may assert against Contractor concerning Contract 1300. In accordance with San Francisco Administrative Code Section 6.22(K), the Director of Transportation will issue Notice of Final Acceptance within one business day of the SFMTA Board of Directors approval of this Contract Modification 147.

6. Final Payment and Release of Retention.

The City shall make final payment described in paragraph 1.h to Contractor on or before June 30, 2023.

In addition to the Final Payment amount described above, as of April 30, 2023, there are \$5,345,408.33 retained funds from progress payments (retention) held in escrow in US Bank, Account Number: 206470000. Upon Final Acceptance, the City will instruct US Bank to release the retained funds (including any additional accrued interest), less amounts the City is required to withhold to satisfy Subcontractor and Supplier stop notices, and other third party legal holds on Contract funds. The City will not release said funds until the SFMTA has received a release from the entity that submitted the hold or stop notice, a court order directing the disposition of those funds or a similar order from a regulatory body. The City will disburse withheld retention funds in accordance with instructions stated in the relevant release, court order or regulatory order.

As of the Effective Date of this Amendment, the City has received notice of the actions listed in the following table, for which it will withhold release of retention in the following amounts:

Upon Final Acceptance, the City will instruct the escrow agent at U.S. Bank to release to Contractor those retention funds that are not required to be withheld to pay stop notices against Contract 1300 funds. Contractor may submit a bond that complies with statutory requirements for release of retained funds as required by Subcontractor and Supplier stop notices.

7. Effective Date

The Effective Date of this Contract Modification 147 is June 6, 2023, conditioned upon the approval of the SFMTA Board of Directors.





8. Guarantees and Warranties

Contractor acknowledges that it is obligated to provide general and special warranties for Work, as provided in Contract 1300.

9. Full and Final Release

- a. The Parties intend that this Amendment fully and finally resolves all Contractor claims for additional compensation and time that Contractor may bring arising from or related to Contract 1300 and Contractor's Work on the Central Subway Project. Contractor does not assert and waives any exceptions, carve-outs, or reservations of rights of any kind to additional compensation or time that would in any way conflict with this Claims Release.
- b. Contractor acknowledges and agrees that the compensation and time extension stated in this Contract Modification 147 is full satisfaction and accord of all compensation and time that the SFMTA may owe Contractor (and any Subcontractor) related to or arising from the matters addressed in this Contract Modification 147 or otherwise arising from or related to Contract 1300 or the Contractor's Work on the Central Subway Project. Said compensation and time extension stated in this Contract Modification constitutes full satisfaction and accord of any and all amounts the SFMTA owes or may owe Contractor, including but not limited to compensation for direct and indirect costs, time extension, delay and related costs and impacts that Contractor has incurred or may incur, labor and materials costs, incidental costs, support costs, acceleration, subcontractor support costs, subcontractors' direct and indirect costs, interest, escalation, and/or any other costs arising from Contractor's performance of the Work and Additional Work (collectively "Damages") on or before the Effective Date of this Amendment, without exception or limitation.
- c. Contractor hereby releases the City from any and all liability for said Damages and any other claims that Contractor has, may, or could allege as arising out or related to compensation or time concerning Contract 1300 or the Central Subway Project, without limitation. This release covers all claims, potential claims, and other requests for Damages whether based in contract, law or equity that may exist, irrespective of whether said claims, potential claims, and other requests for Damages are known, unknown, certified, submitted, or noticed.
- d. Any Work that Contractor has performed after March 31, 2023 (the agreed date of Final Completion) is warranty Work or Incidental Work, and compensation for that Work is included in the final Contract Amount and Contract Time stated in this Contract Modification 147. Any Work that Contractor performs after March 31, 2023 that is necessary to meet requirements of Contract 1300 for Final Completion and Final Acceptance is Incidental Work, and compensation for that Work is included in the final Contract Time stated in this Contract Modification 147.
- e. Contractor agrees that it has not performed any Work for which it could claim further compensation or time extension of any kind after March 31, 2023 (the agreed date of Final Completion). Contractor agrees that Work and Deliverables that it has provided to the SFMTA that are stated in Contract 1300 as conditions of Final Acceptance do not constitute Additional Work or other basis of a claim by Contractor of additional compensation of any kind or basis to request additional Contract Time.
- f. Contractor understands and acknowledges that a risk exists that it has incurred or suffered or may incur or suffer other costs or impacts arising from or related to Contract 1300, and the facts and circumstances of those costs and impacts were unknown,

unsuspected, or unanticipated as of the Effective Date of this Agreement. Contractor assumes this risk and agrees that the foregoing release shall in all respects be effective and not subject to termination or rescission, and that Contractor waives the protections provided by California Civil Code section 1542. Contractor affirms that it has read, considered, and understands the provisions and significance of California Civil Code section 1542, which states:

SECTION 1542. GENERAL RELEASE. A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER PAYMENT WITH THE DEBTOR OR RELEASED PARTY.

This release does not waive any defenses that Contractor may assert in any action concerning Contract 1300. This release shall be effective upon the SFMTA's issuance of Final Acceptance but shall not affect rights created or preserved by this Amendment.

10. Changes to Contract 1300 Are Limited and Express

This Contract Modification 147 amends Contract 1300 only as to those matters addressed in the Amendment and only as expressly stated in this Amendment. All other provisions of Contract 1300 remain in full and force and effect. Any modification of Contract 1300 must be express and in conformance with the General Provisions and Special Provisions of Contract 1300.
