1801 Evans Avenue, west side, from Rankin Street to 260 feet northerly

### <u>ESTABLISH – NO PARKING, 8 AM TO 10 AM, 1st AND 3rd FRIDAY OF THE MONTH,</u> <u>STREET CLEANING</u>

Colonial Way, unit block, northwest terminus, between the eastern property line of 53 Colonial Way to in front of 42 Colonial Way

## ESTABLISH – RED ZONE

Fulton Street, north side, between the two crosswalks crossing Fulton Street at Clayton (approximately 40' opposite the stem of this T-intersection)

## ESTABLISH – TOW-AWAY, NO PARKING, 10 PM TO 6 AM, EVERYDAY

Loomis Street, both sides, between Oakdale Avenue and Industrial Street

## **ESTABLISH – UNMETERED MOTORCYCLE PARKING**

Folsom Street, south side, from approximately 96' to 110' west of Sherman Street (3 motorcycle

### ESTABLISH – RESIDENTIAL PERMIT PARKING AREA J – ELIGIBILITY ONLY

772-780 Stanyan Street – Residences only (no new signs will be installed)

Coit Tower Parking Lot at the terminus of Telegraph Hill Boulevard (the Monday through Friday regulations would remain the same)

### <u>RESCIND – 30-MINUTE LIMIT, 8 AM TO 9 PM, SATURDAY AND SUNDAY, JUNE</u> <u>THROUGH SEPTEMBER, EXCEPT AREA A PERMITS</u>

Coit Tower Parking Lot at the terminus of Telegraph Hill Boulevard (the Monday through Friday regulations would remain the same)

#### <u>RESCIND – BUS STOP</u>

Last 30X inbound bus stop (AM only) on Howard at The Embarcadero

#### ESTABLISH – RIGHT LANE MUST TURN RIGHT

Northbound Drumm Street at Washington Street

#### **ESTABLISH – NO PARKING, 6' VEHICLE RESTRICTION**

Thomas Street, north side, from Lane Street to 100' westerly

#### **REVOKE – ONE-WAY**

Eddy Street, between Larkin and Leavenworth Streets (2 blocks)

Ellis Street, between Polk and Jones Streets (4 blocks)

## ESTABLISH – RIGHT TURN ONLY
