BACKGROUND INFORMATION / COMMENTS

On April 2, 2025, the SFMTA Board of Directors approved a series of Muni service changes that included the creation of a new bus route, tentatively named the 26 Hayes/Parnassus. This route would be created by combining the existing 6 Haight/Parnassus (west of Masonic Ave) and the 21 Hayes routes (east of Masonic Ave); these two segments would be linked by routing buses along Masonic Avenue between Haight Street and Hayes Street. This service change would come into effect on June 21, 2025.

The changes proposed near the intersection of Masonic and Hayes is intended to improve clearances for the inbound 26 bus making the right turn from northbound Masonic into eastbound Hayes. These changes would also allow for the outbound 26 to make a curbside stop nearside at this intersection (the existing outbound 21 stop at this intersection is farside and would no longer be served by this new routing). Due to the proximity of the newly configured Hayes/Masonic stops, the pair of existing stops at Hayes/Central would be rescinded.

The existing bus zone on Hyde between Fulton and Grove would serve as the inbound-26 terminal. Because this bus zone is also used by the 19, 27, and multiple Golden Gate Transit buses, this proposal includes extending the bus zone to better accommodate all of its uses







Existing 21 Route Map


