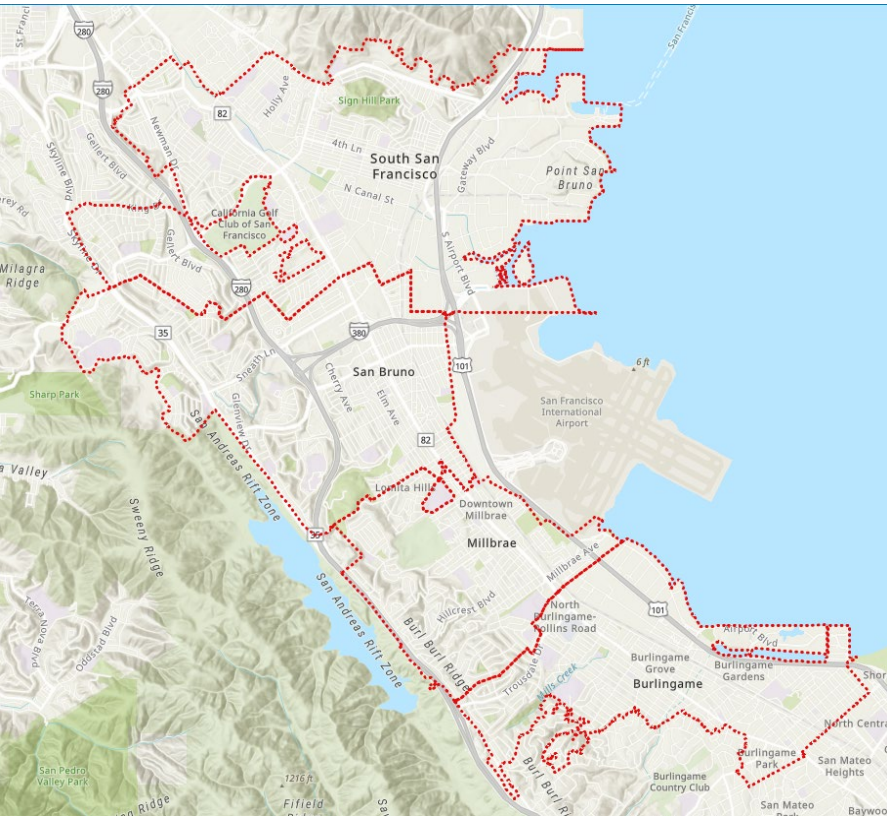

# Taxi Code Reform

- ❖ The SFMTA is working on the next round of review of taxi requirements ([Article 1100 of the Transportation Code](#))
- ❖ Our intent: **continue to modernize rules to allow the taxi industry to innovate and compete, while maintaining safety and consumer protection**
- ❖ Feedback from the taxi industry is an important part of the process
- ❖ Next steps
  - Monthly meetings to discuss potential changes
  - Proposed amendments to the taxi code require approval of the SFMTA Board of Directors
  - Proposed amendments for SFMTA Board consideration in 2026

# Taxi Meter Rate Amendments



❖ Proposed rate amendments:

## Minimum fare from SFO:

- Minimum Fare: **\$24** not including fees
- Based on average fare within Short geofence
- Fare is clear to customers
- Applies 24/7/365
- Drivers still eligible for Short line
- If meter is lower, drivers may charge less

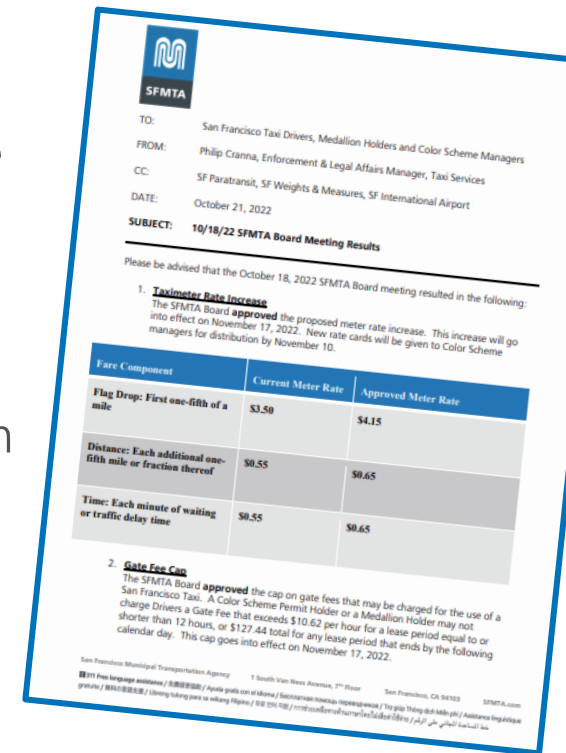

# Taxi Meter Rate Amendments

## ❖ Proposed rate amendments:

### • Meter and a half (Out-of-Town Trips):

- New Proposal: Flat Rate Zones for long distance trips – listed by municipal boundaries for clarity
- Zones to be published on SFMTA website for customer transparency
- Flat Rate based on meter plus distance premium
- Issue solved: driver/passenger disputes

# Proposed Driver Duty Amendments

- ❖ Drivers shall use the most direct route on any trip, unless otherwise specifically requested by the passenger.
  - Prohibits long hauling.

## Status Update:

- ❖ Drivers shall, at the beginning of a trip, inform any passenger whose announced destination falls within the parameters of Section 1124(b)(3) that the fare to be charged will be 150% of the amount registered on the Taximeter.
  - If Driver fails to notify Customer of charge, Driver shall refund Customer the difference in fare. **Still under review**



# Color Scheme Duty to Notify

Update Transportation Code §1106. CONDITIONS APPLICABLE TO COLOR SCHEME PERMITS.

## (o) Required Notifications.

### (5) Death of Medallion Holder.

Require Color Scheme to timely notify the SFMTA in the event of a notice of death of a medallion holder, within a shorter time period. Add fine for noncompliance.

Currently 14 calendar days required

Issue solved: beneficiary notifications for designee holder, medallion usage compliance

# Color Scheme Permits: Status Update

Update Transportation Code §1106. CONDITIONS APPLICABLE TO COLOR SCHEME PERMITS.

## (r)(2) Found Property.

If the Found Property is currency, is of the value of \$100 or more, is either a serialized item or an electronic device or contains owner's identification information, within ~~30~~ **7 calendar** days the Color Scheme Permit Holder or the designee shall transfer the property to the SFMTA.

Issue solved: faster property reunification

# Third-Party Wheelchair Accessible Vehicle Trips

- ❖ Allowing ramp taxis to provide Third-Party WAV trips requires a rule change to the TNC Access for All program regulations by the California Public Utilities Commission (CPUC)
- ❖ Uber requested the CPUC update the rules to allow ramp taxis to provide TNC-originated WAV trips; SFMTA supported this request
- ❖ CPUC finalized decision allowing Third-Party WAV trips
- ❖ **January 29, 2026: SFMTA updated program rules to allow Third-Party WAV trips – applications are now open!**
