8. Discussion and possible action regarding a recommendation from the Citizen's Advisory Council to recommend that the SFMTA dedicate a manager to planning for the E-line including turnaround options or extensions south of CalTrain.

Frank Zepeda recommends a Historical Vehicle Project Manager rather than just an E line manager. He would like details on the job description and have the position report directly to Ed Reiskin.

9. Presentation, discussion, and possible action regarding the 19th Avenue/M-Ocean View project. (Peter Albert, Manager, Urban Planning Initiatives and Liz Brisson, Project Manager)

Liz Brisson stated that the SFCTA recently completed the Feasibility Study for the 19<sup>th</sup> Avenue M Ocean View Project. The SFMTA is now launching the next phase, the Pre-Environmental Study.

Project staff is working in partnership with stakeholders to meet the many needs of the area. Transit speed and access are challenges. The Development Agreement between the City and Parkmerced commits Parkmerced to design and construct a new segment of the M line through Parkmerced. The City has an opportunity to develop a grade that separates the M-Ocean View's crossings of 19<sup>th</sup> Avenue near Stonestown and Parkmerced, and leverage the commitment Parkmerced is making which is valued at \$70 million. The City has until July 2018 to come up with such a project to follow through on its obligations within the Development Agreement. In 2012, the SFCTA began a study to develop and evaluate grade-separated options for the M Ocean View in the Study corridor.

The Longer Subway and Bridge option was found to be the highest performing alternative. This option enables up to four car light-rail trains to serve an M-short line to Parkmerced, thus doubling capacity. It would also decrease light rail travel time in the corridor by 35-45%.

There were two major rounds of outreach conducted during the feasibility study that generated mostly positive feedback. The capital cost in 2013 dollars is estimated to be \$520 million. The final report includes an initial funding strategy that identifies many funding sources. The project could also save up to \$2 million per year in operating costs because of the faster travel time.

With the Feasibility Study completed, the SFMTA has taken on leadership of the project and is kicking off the Pre-Environmental Study phase of the project by preparing a Project Study Report, anticipated by July of 2015, after which environmental review would commence.
