Christine stated that she had three issues with commuter shuttle buses on her block at 26th Street. She suggested that all of the vehicles should be green and energy efficient. The current models emit carbon monoxide. The buses are too big and too tall to travel on such small streets. She proposed the SFMTA allow only a small amount of traffic on 26th Street. There has been some improvement but more need to be done.

Edward Mason stated that commuter shuttles continue to violate the rules including parking in Muni bus stops. The Bauer company shuttles ignore the weight restrictions along 30th Avenue.
