July 17, 2015 PUBLIC HEARING RESULTS

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency held a public hearing on Friday, July 17, 2015, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the proposals listed below. This document summarizes the results of the hearing. Per Section 201 of the City Transportation Code, some items can be implemented by the authority of the City Traffic Engineer. Other items require further approval by the SFMTA Board.

1. ESTABLISH – RED ZONE

8th Street, east side, from Folsom Street to 30 feet northerly (removing general meter #261)

 \Rightarrow Item will be forwarded to SFMTA Board for approval and implementation.

2. ESTABLISH – ONE WAY STREET

Rotteck Street, southbound, between Still Street and Cayuga Avenue

 \Rightarrow Item will be forwarded to SFMTA Board for approval and implementation.

3. ESTABLISH – STOP SIGN

Hearst Avenue, westbound, at Ridgewood Avenue, stopping the stem of this "T" intersection

Item will be forwarded to SFMTA Board for approval and implementation.

4. <u>ESTABLISH – RESIDENTIAL PERMIT PARKING, AREA R, 2-HOUR PARKING, 9 AM</u> <u>TO 6 PM, MONDAY THROUGH SATURDAY, EXCEPT VEHICLES WITH AREA R</u> <u>PERMITS</u>

Ivy Street, both sides, between Octavia and Laguna Streets (400 block, RPP signs on north side only; no parking on south side)

5. <u>ESTABLISH – RESIDENTIAL PERMIT PARKING ELIGIBILITY, AREA V</u> 1100 Ocean Avenue (eligibility only, no signage)

 \implies Item will be forwarded to SFMTA Board for approval and implementation.

6. <u>ESTABLISH – RESIDENTIAL PERMIT PARKING ELIGIBILITY, AREA L</u> 3800 block of Geary Boulevard, south side, between 2nd Avenue and 3rd Avenue (eligibility only, no signage)

Item will be forwarded to SFMTA Board for approval and implementation.
