1. Call to Order

Chairman Nolan called the meeting to order at 1:07 p.m.

2. Roll Call

3. Announcement of prohibition of sound producing devices during the meeting.

Chairman Nolan announced that the ringing of and use of cell phones, pagers and similar soundproducing electronic devices are prohibited at the meeting. He advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. She also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

5. Communications

Chairman Nolan asked that the meeting be adjourned in memory of Norman Bray, former City Traffic Engineer for 30 years.

Board Secretary Boomer stated that Item 18 regarding the Taxi Medallion Program reform had been removed from the agenda at the request of staff.

Chairman Nolan stated that since Item 18 had been removed from the agenda, the closed session would be moved to the end of the meeting.

7. Director's Report (For discussion only)

-Special Recognition Award -Update on Vision Zero -Ongoing Activities

John Haley, Director, Transit recognized Paulo De Souza, construction inspector. Tom Maguire, Director, Sustainable Streets recognized Rod Alatorre, Ofelia Gonzales, Frederick Porche, Philip Nguyen, Yan Lin and Lenise Thomas, school crossing guard trainers. Candace Sue, Director, Communications recognized Charles Belov, SFMTA Webmaster.

Ed Reiskin, Director of Transportation, discussed the recent computer "hack"; legal rulings about the Golden State Warriors Event Center and the T Third Mission Bay loop; J Church signage at Balboa Park; a Vision Zero motorcycle safety campaign and upcoming work at the intersection of Folsom and Howard.

PUBLIC COMMENT:

Herbert Weiner stated that the SFMTA is educating motor cyclists and wondered about bicyclists. They're riding on the sidewalk and going through traffic lights.

Patricia Vaughey stated that a man ran a red light on Divisadero and died. For ten years, the timed lights on Lombard have been wrong. She questioned some of what is happening with Vision Zero. The new buses rattle more than the old ones. She expressed disappointment about what is happening and hope that the outreach to people in the south of Market area is better than what happened in the Marina.

8. Citizens' Advisory Council Report

9. Public Comment

John Giordano discussed the commuter shuttle hub study. It's based on questionable logic and data. He inquired about how the SFMTA would know that people would switch to driving when they hadn't been questioned. If the SFMTA is going to use ridership in a decision making process, there needs to be a more accurate model. Private shuttles are used by a small percent of the population. These shuttles should use private spaces. Using a Muni zone is illegal. If we allow more private entities to use public land, there will be chaos. He urged the SFMTA to revise the report and consider a hub model.

Herbert Weiner stated that the SFMTA has increased bus fares and removed bus stops. He asked for a medical finding of the physical impact of walking a quarter mile to a bus stop for seniors and people with disabilities. It's frustrating that signs aren't accurate. The Board has a closed mind, especially with the L Taraval issue. He would like the Board to inform cyclist that they're violating the law when they ride on sidewalks. Tariq Mehmood discussed taxi issues. The industry is a fool's game. Emails from taxi staff aren't sent to drivers so drivers don't know what's going on. Drivers are barely making \$30-40/day. He has asked repeatedly that something be done about the Taxi Task Force but nothing has been done. Nothing is being done about the Flywheel taximeter. The SFMTA needs to solve issues and remove Kate Toran.

- D. ESTABLISH ABILITY OF PERMITTED COMMUTER SHUTTLE BUS TO USE MUNI BUS ZONE - Divisadero Street, east side, from Bush Street to 134 feet northerly
- E. RESCIND YELLOW METERED LOADING ZONE, 30-MINUTE TIME LIMIT, 8 AM TO 6 PM, MONDAY THROUGH FRIDAY - Divisadero Street, east side, from 5 feet to 30 feet south of Pine Street
- F. ESTABLISH YELLOW METERED LOADING ZONE, 30-MINUTE TIME LIMIT, 8 AM TO 6 PM, MONDAY THROUGH FRIDAY - Divisadero Street, east side, from 134 feet to 178 feet north of Bush Street
- G. ESTABLISH GREEN METERED PARKING, 30-MINUTE TIME LIMIT, 9 AM TO 6 PM, MONDAY THROUGH FRIDAY - Divisadero Street, east side, from 50 feet to 94 feet south of Pine Street. (Explanatory documents include a staff report, map, diagram and resolution.)

18. Amending Transportation Code Division II, Article 1100, Sections 1101 – 1109, 1113, 1114, 1116 – 1118, 1124 to reform the taxicab medallion system by eliminating the requirement that only San Francisco taxi drivers be allowed to purchase a medallion, eliminating the driving requirement for medallion holders, allowing medallions to be held by business entities as well as groups of individuals, allowing up to a medallion holder to hold a maximum of 50 medallions, eliminating requirements that drivers shift change on property, eliminating the requirement for taxi companies to have a business address in San Francisco, eliminating certain restrictions on spare vehicles, requiring in-taxi equipment to be integrated with the taximeter, requiring that new Color Scheme applicants have at least 50 Medallions to be eligible for a permit and to operate, removing outdated language regarding paper waybills, medical examination requirements for drivers, dispatch service standards and Passenger Information Monitors, modernizing the code to streamline color scheme

reporting requirements, eliminating the requirement for color schemes to list its phone number in the Yellow Pages and amend Transportation Code Division II, Article 300 Sections 310 and 320 to increase the fine related to the continuous operation requirement, eliminate the fines for noncompliance with requirements that are proposed to be eliminated, such as the full time driving requirement, to renumber based on proposed amendments and to reduce the fee from \$1,900 to \$750 for color schemes for continued operation of a medallion upon the death of a medallion holder or a medallion suspension. (Explanatory documents include a staff report, amendment and resolution. The proposed action listed above is the Approval Actions as defined by S.F. Administrative Code Chapter 31.)
