BRIEF DESCRIPTION:

Amending Transportation Code, Division II, Section 801 to revise parking restrictions at various locations.

SUMMARY:

- Since the SFMTA manages on-street parking throughout the City, SF Public Works is requesting the SFMTA to enact parking restrictions to support their "Pit Stop Program."
- Proposed parking restrictions at 3298 Washington Street were requested by the Portuguese Consulate and the San Francisco Mayor's Office of Protocol.
- The proposed action is the Approval Action as defined by S. F. Administrative Code Chapter 31.

PURPOSE

Amending Transportation Code, Division II, Section 801 to revise parking restrictions at various locations

STRATEGIC PLAN GOALS AND TRANSIT FIRST POLICY PRINCIPLES

The proposed amendment to the Transportation Code supports the SFMTA Strategic Plan Goals and Objectives indicated below:

Goal 2: Make transit, walking, bicycling, taxi, ridesharing, and carsharing the preferred means of travel

Objective 2.4: Improve parking utilization and manage parking demand

Goal 3: Improve the environment and quality of life in San Francisco Objective 3.2: Increase the transportation system's positive impact to the economy

The proposed amendment to the Transportation Code also supports the SFMTA Transit-First Policy principles indicated below:

- Principle 1: To ensure quality of life and economic health in San Francisco, the primary objective of the transportation system must be the safe and efficient movement of people and goods.
- Principle 3: Decisions regarding the use of limited public street and sidewalk space shall encourage the use of public rights of way by pedestrians, bicyclists, and public transit, and shall strive to reduce traffic and improve public health and safety.

DESCRIPTION

The proposed Transportation Code amendments will revise parking restrictions at ten locations. Nine of these locations were requested by the San Francisco Public Works to support their "Pit Stop Program."

The San Francisco Public Works' Pit Stop Program (<u>http://sfpublicworks.org/pitstop</u>) provides clean and safe public toilets, sinks, used needle receptacles and dog waste stations at certain locations primarily in the Tenderloin and South of Market neighborhoods. The program uses portable toilets brought to and from sites daily after overnight servicing at a remote location. The Pit Stop facilities are only located at these sites during weekdays (Monday to Friday) throughout the day. All the Pit Stop facilities are staffed by attendants who help ensure that toilets are well maintained and used for their intended purpose. The proposed parking restrictions at nine locations will restrict parking between certain hours, Monday to Friday, except for SF Public Works vehicles only.

Temporary no-parking signs are now used at these nine locations. Since these signs are made of paper and contain a movable base, SF Public Works is encountering sign durability issues as well as vehicles not adhering to the parking restrictions. As a result, SF Public Works is requesting

permanent no-parking signs which will be installed in the sidewalk with metal sign posts to help with durability and ensure vehicle compliance with the parking restrictions. In order to restrict parking at these locations permanently, an amendment to the Transportation Code is required.

The proposed nine locations for these parking restrictions are as follows:

- **6th Street** The east side of 6th Street, from Jessie Street to 32 feet northerly, from 12 p.m. to 9 p.m.
- **16th Street** The north side of 16th Street, from 95 feet to 117 feet west of Capp Street, from 10 a.m. to 7 p.m.
- Ellis Street The south side of Ellis Street, from 144 feet to 194 feet west of Taylor Street, from 1:30 p.m. to 10:30 p.m.
- **Golden Gate Avenue** The south side of Golden Gate Avenue, from 21 feet to 66 feet east of Jones Street, from 1 p.m. to 10 p.m.
- **Haight Street** The south side of Haight Street, from Buena Vista Avenue West to 40 feet easterly, from 11 a.m. to 8 p.m.
- **Hyde Street** The east side of Hyde Street, from 44 feet to 72 feet north of Turk Street, from 12:30 p.m. to 9:30 p.m.
- Mission Street The west side of Mission Street, from 23 feet to 41 feet south of Sycamore Street, from 11:30 a.m. to 8:30 p.m.
- Natoma Street The south side of Natoma Street, from 9th Street to 63 feet easterly, from 9:30 a.m. to 6:30 p.m.
- Valencia Street The west side of Valencia Street, from 59 feet to 100 feet south of McCoppin Street, from 10:30 a.m. to 7:30 p.m.

The tenth location is adjacent to the Portuguese Consulate in Pacific Heights and will have restricted parking from 8 a.m. to 6 p.m., Monday to Friday, except vehicles displaying a permit issued by the Portuguese Consulate. The consulate currently has a 15-foot white zone for loading and short term parking at 3298 Washington Street. The consulate has expressed to SFMTA staff and the Mayor's Office of Protocol that the white zone alone does not provide sufficient parking for their staff, visitors and vendors who need curb access. The Russian and Korean consulates, also in Pacific Heights, have designated parking restrictions. The Portuguese Consulate and Mayor's Office of Protocol have requested that the SFMTA extend the same parking restrictions to ensure parking availability for the Portuguese Consulate to conduct official business.

The proposed parking restriction is as follows:

• Washington Street – The north side of Washington Street, from 20 feet to 35 feet east of Presidio Avenue, from 8 a.m. to 6 p.m.

STAKEHOLDER ENGAGEMENT

In accordance with SFMTA procedures, public hearings were held to consider the proposed changes. The public hearing for the nine Pit Stop Program locations was held on February 17, 2017. The public hearing for the Portuguese Consulate location was held on April 14, 2017.

A notice indicating the public hearing date, time, location, and purpose was posted in the area affected by these parking restrictions at least one week in advance of the hearing date. No public comment was received either in favor or against the proposed restrictions at the two public hearings.

In addition, the owners of the parking lots located at the Pit Stop Program's Jessie Street and Hyde Street locations were contacted to notify them of the proposed parking restrictions. Neither business voiced any objection.

The SFMTA received a letter from the San Francisco Consulate General of Portugal on September 15, 2014, and an email from the San Francisco Mayor's Office of Protocol on September 23, 2015 requesting the proposed parking restriction at 3298 Washington Street.

ALTERNATIVES CONSIDERED

The only alternative considered is not enact these permanent parking restrictions. Staff decided to proceed with the proposed restrictions to improve curb access for the Pit Stop Program and restrict parking near the Portuguese Consulate.

FUNDING IMPACT

There is no financial impact to the City. The installation and maintenance costs for signs are budgeted in the SFMTA's existing operating budget.

ENVIRONMENTAL REVIEW

The proposed parking and traffic modifications are subject to the California Environmental Quality Act (CEQA). Title 14 of the California Code of Regulations Section 15301 provides an exemption from environmental review for the operation, repair, maintenance, or minor alteration of existing highways and streets, sidewalks, gutters, bike and pedestrian trails, and similar facilities.

On February 3, 2017, the SFMTA, under authority delegated by the Planning Department, determined (Case No. 2017-002093ENV) that the proposed parking and traffic modifications for the SF Public Works Pit Stop Program locations are categorically exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15301. On March 31, 2017, the SFMTA, under authority delegated by the Planning Department, determined (Case No. 2017-004249ENV) that the proposed parking and traffic modification related to the Portuguese Consulate location is categorically exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15301. The proposed action is the Approval Action as defined by S. F. Administrative Code Chapter 31.

Copies of the CEQA determinations are on file with the Secretary to the SFMTA Board of Directors, may be found in the records of the Planning Department at 1650 Mission Street in San Francisco, and are incorporated herein by reference.

WHEREAS, The Portuguese Consulate and Mayor's Office of Protocol have requested that the SFMTA extend the same parking restrictions as the Russian and Korean Consulates; and,

WHEREAS, On February 3, 2017, the San Francisco Municipal Transportation Agency, under authority delegated by the Planning Department, determined that the proposed parking and traffic modifications, set forth as items A through I above, are categorically exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15301, and the proposed action is the Approval Action as defined by S. F. Administrative Code Chapter 31; and,

WHEREAS, On March 31, 2017, the San Francisco Municipal Transportation Agency, under authority delegated by the Planning Department, determined that the proposed parking and traffic modification listed in item J above is categorically exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15301, and the proposed action is the Approval Action as defined by S. F. Administrative Code Chapter 31; and,

WHEREAS, Copies of the CEQA determinations are on file with the Secretary to the San Francisco Municipal Transportation Agency Board of Directors, may be found in the records of the Planning Department at 1650 Mission Street in San Francisco, and are incorporated herein by reference; now, therefore be it

RESOLVED, That the San Francisco Municipal Transportation Agency Board of Directors approves the parking and traffic modifications set forth in items A through J above; and, be it further

RESOLVED, That the San Francisco Municipal Transportation Agency Board of Directors amends Transportation Code, Division II, Section 801 to revise parking restrictions at various locations.

[Transportation Code – Parking Restrictions by Location]

Resolution amending Division II of the Transportation Code regarding designated parking restricted locations.

NOTE: Additions are <u>single-underline Times New Roman</u>; deletions are <u>strike through Times New Roman</u>.

The Municipal Transportation Agency Board of Directors of the City and County of San Francisco enacts the following regulations:

Section 1. Article 800 of Division II of the Transportation Code is hereby amended by revising Section 801(c), to read as follows:

SEC. 801. PARKING RESTRICTIONS BY LOCATION.

(a) It shall be a violation of Division I, Section 7.2.42 (Parking Restrictions) for any person to Park any vehicle, whether attended or unattended, in any of the locations listed below during times when Parking is restricted without displaying a valid permit for Parking in that location. A permit issued for Parking pursuant to this Article does not exempt a vehicle from street-cleaning Parking restrictions. These parking restrictions shall not apply to any state, federal, or foreign consulate vehicle parked to carry out official government business.

(b) **Removal Authorized**. Pursuant to the authority of Vehicle Code Section 22651(n) any vehicle Parked in violation of this Section 801 may be removed by the SFMTA or SFPD.

(c) Restricted Locations:

- (1) 2nd Street, Standford Street, and Townsend Street.
 - (A) Locations:

(i) 2nd Street, west side, from Townsend Street to 100 feet northerly (100-foot zone);

(ii) Stanford Street, east side, from Townsend Street to 100 feet northerly (100-foot zone); and

(iii) Townsend Street, north side, between 2nd and Stanford

Streets.

- (B) Time: All times.
- (C) **Exempt Vehicles:** City-owned vehicles displaying a permit issued

by the SFMTA.

(2) 6th Avenue.

In enacting this ordinance, the San Francisco Municipal Transportation Agency Board of Directors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, letters, punctuation marks, charts, diagrams, or any other constituent parts of the Transportation Code that are explicitly shown in this ordinance as additions or deletions in accordance with the "Note" that appears under the official title of the ordinance.
