## ORDER OF BUSINESS

# 1. Call to Order

Chairman Weaver called the meeting to order at 5:36 p.m.

5. Report of the Chair (For discussion only)

6. Public Comment:

Edward Mason gave an update on the corporate commuter shuttle buses in Noe Valley. The white zone at 24<sup>th</sup> and Church streets continues to be a problem. Automobiles are blocking the space. The white zone is only operational between 6 a.m. and 10 a.m. but there are buses stopping outside of that time frame. Chariot is a growing issue in Noe Valley. They take a spot to drop off people on the fly wherever they can, including yellow zones. They're also operating on weight restricted streets. It's an ongoing problem of enforcement. Neighborhood observations have to be the enforcement. It's unacceptable.

David Pilpel stated that CAC Member Neil Ballard did a fine job presenting at the SFMTA Board meeting on March 20<sup>th</sup>. He suggested that resolutions passed by the CAC be included with the SFMTA Board packet so that the public can be informed. He stated that the Service Equity Strategy and service changes were approved prior to them being heard by the CAC. It's important for the CAC to hear presentations and make recommendations before the Board acts.

Travis Fox, Chief Performance Officer, presented the item.

### PUBLIC COMMENT:

Edward Mason suggested that staff include the word "reliability" in the mission statement. Recently, he was witness to five J Church trains in a row. This was around 10 a.m. Half the J Church fleet was within three blocks. The SFMTA has to build reliability. He inquired what is causing the bunching. Mr. Mason suggested that Uber and Lyft be extracted out of vehicle miles traveled (VMT). There needs to be a definition of what VMT is.

David Pilpel stated that the SFMTA Strategic Plan is aspirational. He is impressed with the tweaks that have been made since it was last presented to the CAC. The language is good and useful. There are a lot of different metrics that track speed and efficiency. He is good with it.

Sean Kennedy, Manager, Muni Forward, presented the item.

### **PUBLIC COMMENT:**

Edward Mason stated that the SFMTA Board said the expansion will be with a state funding grant. He inquired if it is going to replicate "Free Muni" from Google when there isn't ongoing funding. The SFMTA is taking a risk by doing it now and not having funding for it in the future. At the Land Use Committee meeting, Supervisor Safai endorsed Chariot. Mr. Mason inquired what the true capacity is in the subway. He also inquired what the impact will be if SB 827 passes and the City is rezoned.

David Pilpel stated that analyzing every Muni line and neighborhood makes sense for all neighborhoods. All of the lines need to be periodically reviewed. It shouldn't just be limited to equity neighborhoods. The answer shouldn't just be more service and better line management. The real issue is subway capacity. Mr. Pilpel strongly encouraged the CAC to have Sean Kennedy back in six months to follow up. West Portal is a mess and Embarcadero is a bottle neck.

9. Presentation, discussion, and possible action regarding the SFMTA FY 2019-2020 Budget. (Sonali Bose, Director, Finance & Information Technology. Explanatory documents include a slide presentation.)

### PUBLIC COMMENT:

Edward Mason asked what the next step is in creating a system where the commuter shuttles pay beyond cost recovery. He inquired if a tax initiative should be initiated and stated that there is support in the neighborhoods for that. The board didn't take any action or make a comment on it.

David Pilpel stated that he doesn't have a strong policy or revenue opinion on Sunday parking. There should be outreach to the business community prior to any action being taken. The Board gave direction to staff on a number of things involving the budget, though they did not vote. He is still unclear about the below-the-line issues within the budget. He is not convinced that there's room in the subway for additional trains.

The problem that is not being dealt with is the bottleneck at West Portal. The intersection at West Portal and Ulloa streets needs to be examined. That's the problem. Not the number of stops. He stated that he supports the CAC motion but the stops are not the issue.

The SFMTA CAC supports and recommends the reinstatement of the inbound stop at Taraval 17th and Avenue as it is a vital stop for residents carrying bags of groceries using the L Taraval line.
