- 3. A copy of the current California vehicle registration.

The registered owner name must be the same individual holding the lease/title and business certificate. Business owners may assign a permit to one employee or lessee by providing written authorization on company letterhead.

Shared office space with one common entry is considered one business address and will only be eligible for one **Business Permit.**

- The annual permit fee for passenger vehicles is \$144 (\$71 if the permit area expires in less than six months).
- The annual permit fee for motorcycles is \$108 (\$54 if the permit area expires in less than six months).

- One-Day permits are also available for a fee between \$6 and \$13 depending on the quantity ordered. Each household in a residential parking permit zone may purchase up to 20 per calendar year to use for rental cars, guests, etc. Please see specific ordering information on back of this page.
- Short term permits can also be purchased in 2, 4, 6, & 8 week increments. Visit www.sfmta.com/rpp for more information.

Applying for a permit for a new vehicle and do not have license plates yet? You can receive a 90 day temporary permit which will be converted to a standard permit once the license plates have been received.

Prepaid One-Day Permits

Buy prepaid One-Day permits for rental cars, guests, etc. when purchasing your annual parking permits or as you need them. These non-refundable permits offer flexibility and convenience by allowing you to scratch off the corresponding date on the permit when it is used.

If you currently have a vehicle in your name and address with a valid San Francisco residential parking permit you need only to submit this order form. If you do <u>not</u> have a vehicle in your name and address with a valid San Francisco residential parking permit you will need to submit current copies of two (2) of the following documents with resident's name and permit address.

- □ Current utility bill or bank statement, with resident's name and permit address (no cellphone bills)*
- □ Vehicle insurance policy or card with resident's name and permit address
- □ Current rental lease agreement or proof of ownership with resident's name and permit address

Pricing Examples and Totals:

1) Purchasing 7 permits:

 1^{st} - 5^{th} are priced at \$6. The 6^{th} and 7^{th} are priced at \$8.

Total purchase price $(5 \times \$6) + (2 \times \$8) = \$46$

2) Purchasing 20 permits:

 $1^{st} - 5^{th}$ are priced at \$6. $6^{th} - 15^{th}$ are priced at \$8. $16^{th} - 20^{th}$ are priced at \$13.

Total purchase price (5x\$6) + (10 x \$8) + (5 x \$13) = \$175
