ORDER OF BUSINESS

1. Call to Order

Chair Borden called the meeting to order at 1:00 p.m.

2. Roll Call

3. Announcement of prohibition of sound producing devices during the meeting.

No announcement made.

4. Approval of Minutes

No public comment.

On motion to approve the minutes of the February 16, 2021 Regular Meeting minutes: unanimously approved.

5. Communications

Chair Borden discussed the virtual meeting and expressed appreciation to staff for their work to enable the meeting to be held via teleconference. Board Secretary Celaya reviewed how members of the public could watch the meeting and address the Board.

Chair Borden announced that the meeting would be adjourned in honor of Director Brinkman's father, Dr. Charles Rudolph Brinkman, who passed away.

6. Introduction of New or Unfinished Business by Board Members

Director Lai asked if the SFMTA could post on the website the percentage of staff that have been vaccinated.

PUBLIC COMMENT:

Hayden Miller stated that he supports having as much data as possible online but asked that the SFMTA ensure that the data is accurate. He finds some of the data online difficult to believe such as the number

of masks being made available. The Agency should also ensure that taxi drivers, contractor employees and essential staff are told when they are eligible to receive the vaccine.

7. Director's Report (For discussion only)

-Ongoing Activities

Director Tumlin discussed SFMTA staff involvement in the Englander House move from Franklin to Fulton Street, Vision Zero, federal funding, the Transportation Recovery plan, Scooter allocation, Connect SF and return of the F line and cable car service.

PUBLIC COMMENT:

Richard Rothman asked the Board to look at the big picture when making changes to the Great Highway. This is a mess for the Veterans Hospital and for residents from the Richmond district that commute down to the Peninsula. 19th Avenue and Sunset Boulevard can't handle the traffic. 19th Avenue is backed up. Traffic going through Golden Gate Park is causing pollution. He suggested experimenting with making one lane for pedestrians and bicycles and one side for cars.

Aleta Dupree is encouraged by the scooters permit process especially with the addition of the adapted scooters. She wants to see what they look like because she likes options and wants to use them. She supports a sustainable electric shared scooter program because they are helpful to persons with disabilities. The F line needs to go all the way to Fisherman's Wharf and the Ferry Building. The line needs to continue as close to 5th street as possible. She encouraged the Board to make every effort to turn that line back on.

8. Citizens' Advisory Council Report

No report.

9. Public Comment

Hayden Miller discussed the Proof of Payment (POP) staffing that hasn't been out in the public the way the SFMTA blog suggested. POP staff isn't checking riders. He wants to see POP staff on the buses helping with mask compliance. The SFMTA has a budget issue but the lack of parking enforcement is costing loss of revenue. Every weekend at the Great Highway cars are parked on the shoulder and no one cites these vehicles. The same thing is happening with sidewalk parking. POP and Parking Control Officer deployment needs to be changed.

Richard Rothman stated that he is disturbed by the Controller's report on construction accountability. The Board needs to hold a hearing on it. He questioned why the city should give finding to the SFMTA and suggested funding be transferred to Public Works. He asked why the box installed on the 5R route wasn't done at the same time as the other safety improvements. A Mission Local article questioned if the SFMTA is going to survive.

Aleta Dupree stated that it is important to get the subway open. The SFMTA needs to plan their service to minimize transfers. Passengers with disabilities may be passed up because they are boarding vehicles with too many people already onboard. Pass ups shouldn't happen, especially for wheelchair users. Science-based protocols are needed to determine how many people wearing masks can ride the bus. She asked the Board to consider the future when making improvements.

Sam Tadessi discussed the Locally Based Enterprise (LBE) ordinance. He wants the SFMTA to act on ensuring the requirement for San Francisco Black owned businesses is met. He is frustrated that there has been no enforcement of the requirement. There are unfair and discriminatory practices taking place with the parking garage contracts. He'd like his contract with the SFMTA restored under the LBE ordinance. He has been with the SFMTA for 20 years.

Shalana Willis discussed the unfair unilateral bid forced on SFMTA station agents. She asked the Board to ask Julie Kirschbaum to return to the negotiations. Station agent staff feel violated and would like to see this situation get resolved.

Herbert Weiner stated he plans to drive on the Slow Streets because they are better for him as a motorist. The Slow Streets create congestion.

- 12. Approving the proposed traffic modification associated with the "Twin Peaks for All" project as follows:
 - A. ESTABLISH ROAD CLOSURE, EXCEPT EMERGENCY VEHICLES AND BICYCLES Twin Peaks Boulevard, between Christmas Tree Point Road and Burnett Avenue. (Explanatory documents include a staff report, resolution and options. The proposed action listed above is an Approval Actions as defined by S.F. Administrative Code Chapter 31.)

LaMonte Bishop, Manager of Government Affairs, San Francisco Recreation and Park Department, stated that SF Rec and Park supports the option proposed by staff. This option creates a dedicated space for people biking to Christmas Tree Point. Since the outset of the pandemic, people look to our parks for well-being during this challenging time. While many enjoy the access, there are some issues which impact the community and we have gates, the police department and the department of public works to address these concerns. We urge the Board's support of this proposal.

Megan Imperial, on behalf of Supervisor Melgar, stated that the supervisor received comments from constituents concerning the proposed modifications. The supervisor would like to see the deployment of ambassadors to assist the public with navigating the changes. She is supportive of this proposal and would like to see staff monitor the impacts of the changes including Vision Zero risks.

Erin Mundy, on behalf of Supervisor Mandelman, stated that the supervisor hopes that through the Twin Peaks for All project, the SFMTA will a long term plan that preserves the many benefits of increased open space while mitigating the negative impacts to the neighborhood. Specifically, consider keeping the Christmas Tree Point parking lot overnight, ensure access to the top of Twin Peaks for those who are mobility impaired and preserve the existing SFMTA street restriction on passenger vehicles with more than nine passengers, which currently prohibits tour buses from accessing Twin Peaks Boulevard through the Burnett Avenue gate.

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions</u>: Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
