FOR PROPOSED PARKING & TRAFFIC CHANGES

Pursuant to SFMTA Order No. 5787 adopted June 23, 2017, the San Francisco Municipal Transportation Agency will hold a public hearing to solicit public input on the following proposed changes. The hearing will be held as follows:

Date/Time: Friday, July 7, at 10:00 am
Location: Room 416 (Hearing Room 4), City Hall, San Francisco
(located on Van Ness Avenue between McAllister and Grove Streets)

1. **ESTABLISH –RESIDENTIAL PERMIT PARKING AREA AA, 2-HOUR PARKING, 8 AM TO 6 PM, MONDAY THROUGH FRIDAY, EXCEPT VEHICLES WITH AREA AA PERMIT**
 - A. Coleridge Street, both sides, between Coso Avenue and Esmeralda Avenue
 - B. Coso Avenue, both sides, between Precita Avenue and Winfield Street
 - C. Esmeralda Avenue, both sides, between Winfield Street and Elsie Street
 - D. Fair Avenue, both sides, between Mission Street and Coleridge Street
 - E. Lundy's Lane, both sides, between Coso Avenue and Fair Avenue
 - F. Mirabel Avenue, both sides, between Coso Avenue and Shotwell Street
 - G. Montezuma Street, both sides, between Coso Avenue and Shotwell Street
 - H. Powers Street, both sides, between Mission Street and Coleridge Street
 - I. Precita Avenue, both sides, between Mission Street and Folsom Street
 - J. Prospect Avenue, both sides, between Esmeralda Avenue and Virginia Avenue
 - K. Shotwell Street, both sides, between Bessie Street and Stoneman Street
 - L. Winfield Street, both sides, between Coso Avenue and Esmeralda Avenue

Items denoted with an asterisk () can be approved by the City Traffic Engineer after the public hearing and such approval constitutes the CEQA **Approval Action** under S.F. Administrative Code Section 31.04(h). Otherwise, the SFMTA Board will make the final approval at a later date based on the outcome at the public hearing.*

California Environmental Quality Act (CEQA) Appeal Rights under Chapter 31 of the San Francisco Administrative Code: For **Approval Actions**, the Planning Department has issued a CEQA exemption determination or negative declaration, which may be viewed online at <http://www.sf-planning.org/index.aspx?page=3447>. Following approval of the item by the SFMTA City Traffic Engineer, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16, typically within 30 calendar days of the Approval Action. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors or other City board, commission or department at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision
