SFMTA Public Hearing Geary Boulevard Improvement Project

The Geary Boulevard Improvement Project is the second phase of improvements proposed on Geary Boulevard. This project aims to build on the success of the eastern Geary corridor improvements by making similar transit and safety upgrades between 34th Avenue and Stanyan Street.

Geary 街 改善工程旨在改善 Geary 街在 34 大道 和 Stanyan 街之間路 段的交通和安全。此項工程包括新的公交專用車道、公車站遷址、交通 信號燈升級以及公車站和十字路口的人行道擴建。 此項工程公聽會將 於 8 月 15 日星期二下午 1 點在市政廳 (地址: 1 Dr. Carlton B. Goodlett Place)的 400 號會議室舉行。

В рамках проекта модернизации Geary Boulevard предлагается оптимизировать движение транспорта и повысить общую безопасность на участке между 34th Avenue и Stanyan Street. Проект предусматривает выделение новых полос для общественного транспорта, изменения автобусных остановок, модернизацию светофоров, а также обустройство расширений тротуаров на автобусных остановках и углах перекрестков. A public hearing for the proposals below will be held on Tuesday, August 15 to take public comment, discuss and vote on adoption of the Geary Boulevard Improvement Project's parking and traffic changes:

- Installing transit lanes between 28th and 15th avenues. To make room, angled parking on Geary would be converted to parallel parking.
- Transit improvements, including relocating 10 bus stops, removing two closelyspaced stops, new bus bulb-outs and lengthening bus zones that are too short to accommodate two buses.
- Safety improvements, including pedestrian bulb-outs, daylighting, expanded median refuges and left-turn restrictions at key intersections.
- Curb space changes to accommodate business loading needs; and converting some parallel parking to angled parking on some cross streets to partially offset parking loss on Geary Boulevard due to project proposals. Total net parking change would be 31 fewer spaces along the two-mile project area, or less than one parking space per block on average.

The SFMTA Board will be asked to decide whether to: 1) approve the project and implement all Quick-Build improvements, including transit lanes, around fall 2023 as recommended by staff; or 2) approve the project but defer implementation of some transit lanes until 2025.

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: The Planning Department has issued a CEQA statutory exemption determination pursuant to Public Resources Code Section 21080.25, which may be viewed online at the Planning Department's website. Action by the SFMTA Board shall constitute the Approval Action for the project for the purposes of CEQA, pursuant to San Francisco Administrative Code Section 31.04(h). Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.
