### Streets Division Directive Order No. 6966

Pursuant to the public hearing 10-day comment period held between January 20, 2026, and January 30, 2026, traffic movement and safety may be improved by the changes approved below.

#### **1. 2nd Avenue between Lake Street and Terminus – Relocating a Commercial Loading Zone**

##### **1a) RESCIND – YELLOW ZONE, COMMERCIAL LOADING, 30-MINUTE LIMIT, 8AM TO 1PM, MONDAY THROUGH FRIDAY, AND 8AM TO MIDNIGHT, SATURDAY AND SUNDAY**

"6" 2nd Avenue, east side, from 72 feet to 92 feet north of Lake Street (20-foot zone)

##### **1b) ESTABLISH – YELLOW ZONE, COMMERCIAL LOADING, 30-MINUTE LIMIT, 12PM TO 4PM, FRIDAY AND SATURDAY, AND 11PM SATURDAY TO 1AM SUNDAY**

"6" 2nd Avenue, east side, from 52 feet to 72 feet north of Lake Street (20-foot zone), Richmond, Supervisor District 1, Broderick Paulo, [broderick.paulo@sfmta.com](mailto:broderick.paulo@sfmta.com).

Per request from the sponsoring temple to relocate loading zones following sidewalk widening. Parking orientation for the commercial loading will be parallel to allow for safe maneuvering.

**Public Comments:** A total of 56 comments in opposition to the proposal were received. Concerns over the loss of residential parking and noise being created by commercial vehicles, particularly late at night, were the primary concerns expressed.

**Decision:** Not approved by the City Traffic Engineer for implementation.

#### **2. Presidio Avenue between Pine Street and California Street – Establishing a Dual-Use Zone**

##### **ESTABLISH – DUAL-USE ZONE: METERED YELLOW ZONE, COMMERCIAL LOADING, 30-MINUTE LIMIT, 8AM TO 4PM, MONDAY THROUGH SATURDAY, AND GENERAL LOADING ZONE, 4PM TO 10PM, TUESDAY THROUGH SATURDAY**

500 Presidio Avenue, east side, from 20 feet to 49 feet south of California Street at meter stall number 504 (29-foot zone), Presidio Heights, Supervisor District 2, Curb Access Program, [ccp@sfmta.com](mailto:ccp@sfmta.com).

Per the request of the adjacent restaurant, this zone would provide space for their commercial deliveries during the day and pickup and drop-off space in the evenings for guests and food deliveries.

**Public Comments:** Three comments in support and three comments in opposition were received. Two residents and one business stated their opposition as the proposal would remove parking which is needed for business clients and residents and there is already limited parking in the area. Three residents expressed their support for the proposal but did note that there are currently issues with double parking and they have trouble getting out of their garage so more enforcement and red curbs may be needed.

**Decision:** Approved by the City Traffic Engineer for implementation.

### 3. Union Street between Gough Street and Octavia Street – Establishing a Commercial Loading Zone

Per the request of the fronting restaurant, the proposed commercial loading zone would provide space for commercial deliveries serving their business. It will be added to an existing part-time bus stop.

**Public Comments:** No comments received.

**Decision:** Approved by the City Traffic Engineer for implementation.

### 4. Bush Street between Franklin Street and Van Ness Avenue – Establishing a Commercial Loading Zone

**ESTABLISH – METERED YELLOW ZONE, COMMERCIAL LOADING, 30-MINUTE LIMIT, 8AM TO 6PM, MONDAY THROUGH SATURDAY**

1558 Bush Street, north side, from 125 feet to 148 feet east of Franklin Street at metered stall number 1530 (23-foot zone), Western Addition, Supervisor District 2, Curb Access Program, [ccp@sfmta.com](mailto:ccp@sfmta.com).

The fronting business has requested commercial loading at this location for deliveries. This zone would also be shared with neighboring businesses.

**Public Comments:** No comments received.

**Decision:** Approved by the City Traffic Engineer for implementation.

Per the request of the sponsoring daycare, the afternoon hours of an existing passenger loading zone would be extended from 5:30pm to 6:00pm to better accommodate pickups.

**Public Comments:** Two parents stated their support for the proposal as the current zone ends before they arrive, forcing parents to double park, causing safety concerns.

**Decision:** Approved by the City Traffic Engineer for implementation.

An existing passenger loading zone would be shifted to accommodate required daylighting under Assembly Bill 413 to improve pedestrian visibility. The hours and days of the zone would be updated to better match the needs of the sponsoring church.

**Public Comments:** One comment in opposition was received stating concerns over the zone being shortened. Staff confirmed with the member of the public that the size of the zone would remain the same.

**Decision:** Approved by the City Traffic Engineer for implementation.
