January 29, 2016 PUBLIC HEARING RESULTS

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency held a public hearing on Friday, January 29, 2016, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the proposals listed below. This document summarizes the results of the hearing. Per Section 201 of the City Transportation Code, some items can be implemented by the authority of the City Traffic Engineer. Other items require further approval by the SFMTA Board.

1. ESTABLISH – LEFT LANE MUST TURN LEFT

Taylor Street, northbound, at Turk Street

Item will be forwarded to SFMTA Board for approval and implementation.

2. <u>ESTABLISH – NO PARKING ANYTIME</u> ESTABLISH – SIDEWALK WIDENING

Church Street, east side, from Duboce Street to 60 feet northerly (12-foot bulb, no parking impacts)

Item will be forwarded to SFMTA Board for approval and implementation of the No Parking regulation.

3. <u>ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 7:00 AM – 8:30 AM AND</u> <u>4:00 PM – 6:00 PM, SCHOOL DAYS</u>

180 Fair Oaks Street, west side, from 12 feet to 52 feet north of 23rd Street (40-foot zone)

 \Rightarrow Item will be forwarded to the City Traffic Engineer for approval and implementation.

4. <u>ESTABLISH – METERED MOTORCYCLE PARKING</u> <u>RESCIND – GENERAL METERED PARKING</u>

8th Street, east sude, from 44 feet to 65 feet north of Brannan Street (replaces general meter parking #557 with 6 motorcycle parking spaces)

Item will be forwarded to the City Traffic Engineer for approval and implementation.

5. <u>RESCIND – PASSENGER LOADING ZONE, 7:30 AM – 8:30 AM AND 1:30 PM – 3:30 PM,</u> <u>SCHOOL DAYS</u> <u>ESTABLISH – PASSENGER LOADING ZONE, 7:30 AM – 8:30 AM AND 2:00 PM – 5:00</u> PM, SCHOOL DAYS

2120 Broadway, north side, from 60 feet to 258 feet east of Webster Street (198-foot zone)

 \Rightarrow Item will be forwarded to the City Traffic Engineer for approval and implementation.

6. <u>ESTABLISH – NO PARKING ANYTIME</u> ESTABLISH – SIDEWALK WIDENING

CITY and COUNTY

Scott Street, east side, from Page Street to 25 feet northerly, (6-foot bulb, no parking impacts)

Page Street, north side, from Scott Street to 25 feet easterly, (6-foot bulb, removes 1 parking space)

Items will be forwarded to SFMTA Board for approval and implementation of the No Parking regulation.

7. <u>RESCIND – STOP SIGNS</u>

Division Street at 9th Street/San Bruno Avenue, keeping this intersection two-way stopcontrolled

No further SFMTA action required. Sidewalk widening is legislated by DPW.
