#### ORDER OF BUSINESS

# 1. Call to Order

Vice Chairman Heinicke called the meeting to order at 1:00 p.m.

# 2. Roll Call

Acting Chairman Heinicke welcomed Director Torres to the SFMTA Board of Directors.

3. Announcement of prohibition of sound producing devices during the meeting.

Vice Chairman Heinicke announced that the ringing of and use of cell phones, pagers and similar sound-producing electronic devices are prohibited at the meeting. He advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. He also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

## 4. Approval of Minutes

On motion to approve the minutes of the May 2, 2017 Regular Meeting: unanimously approved (Borden, Brinkman - absent).

7. Director's Report (For discussion only)

-Update on Vision Zero -Ongoing Activities John Haley, Acting Director of Transportation, discussed the SFMTA's recent bond rating, radio replacement, transit service for the Bay to Breakers race; and projects associated with the Mayor's Vision Zero Executive Directive.

Tom Maguire, Director, Sustainable Streets discussed recent rule making regarding testing automated vehicle legislation and Turk Street bike lanes.

#### PUBLIC COMMENT:

Herbert Weiner welcomed Director Torres who is joining the Board in the midst of serious problems and declining ridership. He wants to know what is being done to protect pedestrians on the sidewalk from cyclists who are not being cited nor arrested. Cyclists have been dragged off bikes and beaten when they tried to run down a pedestrian. He protested the increase in the Fast Passes. The SFMTA has to improve service. The increase in bus fare is ill deserved.

Tariq Mehmood stated that the SFMTA has a billion dollar budget. He questioned the changes on 7<sup>th</sup> Street and all over the city. Bumps and extra ramps can't be seen at night. Lighting is very poor. With LED lights, a driver can see everything. San Francisco doesn't have a single street with LED lights.

8. Citizens' Advisory Council Report

No report.

9. Public Comment

Eileen Boken stated that during the L Taraval community outreach meetings, the community recommended various things such as crosshatching but it was rejected by a committee. Signage was approved but is in English only. She urged colored stencils to create contrast from the transit only lanes. She urged staff to review signage and the use of stencils at additional sites.

David Pilpel stated that he withdrew his environmental review appeal after receiving assurances from SFMTA staff. He expressed concern about the Metro stations downtown. The Powell and Montgomery stations are dark and dirty, and should be cleaned more frequently and have better lighting. More outreach to the homeless should be done. Signage and wayfinding needs to be improved. Signs regarding passenger conduct should be returned. Electronic display signs are often wrong or inconsistent.

Herbert Weiner stated that the SFMTA is about to break up. Services offered by Chariot, Uber and Lyft means reduced transit ridership. There is no reason why Muni can't be the best transportation system in the country. It shouldn't take more than an hour to get from one area in San Francisco to another. Five decades ago, the City had a comprehensive transportation plan but they don't have one now. The SFMTA has tried to solve the problem by making transit service worse and by making people walk <sup>1</sup>/<sub>4</sub> mile to a bus stop. People will scream privatization. If the public transportation system is lost, all of us lose.

Tariq Mehmood discussed the taxi industry and the budget and salaries for the taxi division. Taxi drivers have lost income. The director needs to be fired or resign. The division's budget shouldn't exceed \$200,000 per year. It needs one officer and two clerks. Nobody is buying medallions any longer. People are forfeiting on their loans.

Tone Lee stated that he was at a meeting with the new owner of Flywheel and told him that he would never achieve anything with the SFMTA. Taxi business is declining. The SFMTA taxi leadership is only enjoying a good salary. He also told Flywheel to start as a Transportation Network Company and not as a taxi business. The taxi office has no reforms but just holds meetings. They don't listen to taxi drivers. New York City and Hong Kong don't have color schemes.

## CONSENT CALENDAR

10. All matters listed hereunder constitute a Consent Calendar, are considered to be routine by the San Francisco Municipal Transportation Agency Board of Directors and will be acted upon by a single vote. There will be no separate discussion of these items unless a member of the Board of Directors or the public so requests, in which event the matter shall be removed from the Consent Calendar and considered as a separate item.

(10.1) Approving the following parking and traffic modifications:

- A. ESTABLISH BIKE LANE Bosworth Street, westbound, from 225 feet east of Elk Street to Bosworth Street/O'Shaughnessy Path.
- B. ESTABLISH SIDEWALK WIDENING 1st Street, east side, from Mission Street to 20 feet northerly; 1st Street, west side, from Minna Street to Mission Street; Fremont Street, west side, from Mission Street to 14 feet northerly; Mission Street, north side, from 1st Street to Fremont Street; Mission Street, north side, from 275 feet to 389 feet west of 1st Street; and Mission Street, south side, from 338 feet to 389 feet west of 1st Street.
- C. ESTABLISH NO PARKING ANYTIME Mission Street, north side, from 283 feet to 401 feet west of 1st Street; Mission Street, south side, from 335 feet to 401 feet west of 1st Street.
- D. ESTABLISH MIDBLOCK TRAFFIC SIGNAL Mission Street, at Shaw Alley.
- E. ESTABLISH RED ZONE Teresita Boulevard, west side, from 9 feet to 31 feet north of Marietta Drive curb ramp.
- F. ESTABLISH RESIDENTIAL PERMIT PARKING AREA N, 2-HOUR PARKING, 9 AM TO 6 PM, MONDAY THROUGH FRIDAY, EXCEPT VEHICLES WITH AREA N PERMIT –Balboa Street, both sides, between 8<sup>th</sup> Avenue and 9<sup>th</sup> Avenue.
- G. ESTABLISH RESIDENTIAL PERMIT PARKING AREA L, 2-HOUR PARKING, 8 AM TO 6 PM, MONDAY THROUGH FRIDAY, EXCEPT VEHICLES WITH AREA L PERMIT – 4<sup>th</sup> Avenue, both sides, between Anza Street and Balboa Street.

- H. ESTABLISH RESIDENTIAL PERMIT PARKING AREA L, 2-HOUR PARKING, 8 AM TO 6 PM, MONDAY THROUGH FRIDAY, EXCEPT VEHICLES WITH AREA L PERMITS – 6<sup>th</sup> Avenue, both sides, between Cabrillo Street and Fulton Street.
- I. ESTABLISH RESIDENTIAL PERMIT PARKING AREA Z ELIGIBILITY 3814 and 3820 24<sup>th</sup> Street.
- J. ESTABLISH NO TURN ON RED Market Street, eastbound, at 10<sup>th</sup> Street.
- K. RESCIND TOW-AWAY NO STOPPING EXCEPT PERMITTED CAR SHARE VEHICLES 20<sup>th</sup> Street, north side, from Connecticut Street to 40 feet westerly.
- L. ESTABLISH TOW-AWAY NO STOPPING EXCEPT PERMITTED CAR SHARE VEHICLES 20<sup>th</sup> Street, north side, from Missouri Street to 40 feet easterly.
- M. ESTABLISH BLUE ZONE 20<sup>th</sup> Street, north side, from Connecticut Street to 20 feet westerly. (Explanatory documents include a staff report and resolution. For every parking and traffic modification that received a categorical exemption, the proposed action is the Approval Action as defined by Chapter 31 of the San Francisco Administrative Code.)

Approving and requesting that the Board of Supervisors approve reallocating \$26.2 million of the first issuance of the 2014 Transportation and Road Improvement General Obligation Bond Series 2015A proceeds allocated for projects including Muni Forward Rapid Network and Major Transit Corridor Improvements and approve that such amounts be redirected to Muni Facility Upgrades; and requesting that the Board of Supervisors appropriate \$92.8 million for the second issuance and sale of the GO Bond, Series 2017A, to capital projects including Accessibility Improvements for BART Canopies, Caltrain Upgrades for Caltrain Electrification, Major Transit Corridor Improvements for Better Market Street, Muni Facility Upgrades, Muni Forward Rapid Network, and Pedestrian Safety Improvements and, if the CBOSS project cannot spend down the \$7.8 million within the requirements of the Internal Revenue Code of 1986, the funds will be reallocated to Muni Facility Improvements, Caltrain Electrification, or any other project included within the approved GO bond program; and making findings under the California Environmental Quality Act. (Explanatory documents include a staff report, resolution and financial plan. Some of the projects listed above have already had an Approval Action as defined by Chapter 31 of the San Francisco Administrative Code. For those projects that have not had an Approval Action, the SFMTA Board's approval of funding would constitute the Approval Action.)

<u>California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31</u>: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.
