SAN FRANCISCO MUNICIPAL TRANSPORTATION AGENCY Order # 5769 FOR PUBLIC HEARING

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency will hold a public hearing on Friday, June 2, 2017, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:

1. <u>RESCIND – PART-TIME NO PARKING ZONE, 8:00AM-3:00PM, SCHOOL DAYS</u> De Montfort Avenue, north side, from Ashton Avenue easterly to Jules Avenue

 \implies Item will be forwarded to SFMTA Board for approval and implementation.

2(a). RESCIND – PART-TIME SCHOOL BUS LOADING ZONE, TOW AWAY, NO STOPPING, 7:00AM-4:00PM, SCHOOL DAYS

7TH Street, east Side, from 180 feet to 265 feet north of Harrison Street (85-foot zone)

Item will be forwarded to the City Traffic Engineer for approval and implementation.

2(b). <u>ESTABLISH – PART-TIME SCHOOL BUS LOADING ZONE, TOW AWAY, NO</u> <u>STOPPING, 7:00AM-4:00PM, SCHOOL DAYS</u> 7th Street, east Side, from 142 feet to 265 feet north of Harrison Street (123-foot zone)

3. <u>ESTABLISH – RAISED CROSSWALK</u> Hudson Avenue at Keith Street, north crossing Hudson Avenue at Reuel Court, north crossing

4. ESTABLISH - RED ZONE

Progress Street, west side, from 52 feet to 67 feet north of Whitney Young Circle

Item will be forwarded to SFMTA Board for approval and implementation.

5. ESTABLISH – STOP SIGNS

Park Street, eastbound and westbound, at Leese Street, making this intersection an all-way STOP

 \Rightarrow Item will be forwarded to SFMTA Board for approval and implementation.

6. ESTABLISH – PERPENDICULAR PARKING

Ashton Avenue, west side, from Grafton Avenue to 425 feet southerly

 \Rightarrow Item will be forwarded to SFMTA Board for approval and implementation.

7. <u>ESTABLISH – RESIDENTIAL PERMIT PARKING AREA N, 2 HOUR PARKING 9 AM TO 6</u> <u>PM, MONDAY THROUGH FRIDAY</u>

California Street, 5300 block, between 15th Avenue and 16th Avenue

Item will be forwarded to SFMTA Board for approval and implementation.

8. <u>ESTABLISH – TOW-AWAY, NO PARKING ANYTIME</u> Point Lobos Avenue, northside, from El Camino del Mar to 185' westerly

Item will be forwarded to SFMTA Board for approval and implementation.

9. ESTABLISH - NO LEFT TURN ON RED

Otis Street, southbound, at Gough Street at McCoppin Street

Item will be forwarded to SFMTA Board for approval and implementation.

10. ESTABLISH - NO PARKING ANYTIME

South Van Ness Avenue, east side, from Howard Street to 40 feet northerly

Item will be forwarded to SFMTA Board for approval and implementation.

11(a). <u>ESTABLISH – RESIDENTIAL PERMIT PARKING AREA G, 2-HOUR PARKING, 8 AM</u> <u>TO 6 PM, MONDAY THROUGH FRIDAY, EXCEPT VEHICLES WITH AREA G</u> <u>PERMITS</u>

Sutter Street, both sides, between Fillmore Street and Webster Streets

11(b). <u>RESCIND – ONE HOUR TIME-LIMITED PARKING</u> Sutter Street, south side, between Fillmore and Webster streets

11(c). <u>ESTABLISH – GENERAL METERED PARKING, NO TIME LIMITS, 9 AM TO 6 PM,</u> <u>MONDAY THROUGH SATURDAY</u>

Sutter Street, south side, from 100 feet east of Fillmore (end of bus zone) to Webster Street (establishes up to 14 full-sized metered spaces)

Staff will review public comments to determine which items, if any, should be forwarded to the SFMTA Board for approval and implementation.

12. ESTABLISH-15 MPH SCHOOL SPEED LIMIT WHEN CHILDREN ARE PRESENT

- A. Hudson Avenue between Ardath Court and Whitney Young Circle
- B. Hudson Avenue between Whitney Young Circle and Bertha Lane

Items will be forwarded to SFMTA Board for approval and implementation.

14. ESTABLISH-TWO-WAY STREET

Eddy Street, between Mason and Leavenworth streets (3 blocks)

Item will be forwarded to SFMTA Board for approval and implementation, with a report about support and opposition.

15. ESTABLISH – NO PARKING EXCEPT BICYCLES ESTABLISH – BIKE SHARE STATION

Shrader Street, east side, from 12.5 feet to 97.5 feet south of Haight Street

Market Street, south side, from 130 feet to 230 feet east of 2nd Street

28(c). <u>ESTABLISH – PASSENGER LOADING 6AM TO 11PM, DAILY</u> Powell Street, west side, from 168 feet to 180 feet north of Post

Staff will consider opposition to determine if this should be forwarded to the City Traffic Engineer for approval and implementation.

28(d). <u>ESTABLISH – YELLOW METERED LOADING ZONE, 7 AM TO 1 PM, MONDAY</u> <u>THROUGH SATURDAY</u>

Powell Street, west side, from 180 feet to 222 feet north of Post Street

Staff will consider opposition to determine if this should be forwarded to the City Traffic Engineer for approval and implementation.

30. <u>ESTABLISH – NO PARKING EXCEPT BICYCLES</u> <u>ESTABLISH – BIKE SHARE STATION</u>

Townsend Street, north side, from 4.5 feet to 104 feet west of 5th Street

Item will be forwarded to the City Traffic Engineer for approval and implementation.

31. ESTABLISH-CLASS II BIKEWAY

- A. Sanchez Street, southbound, from Henry Street to Market Street (bike lane);
- B. Sanchez Street, northbound, from Market Street to 40 feet southerly (bike lane);
- C. Octavia Boulevard, southbound, from Waller Street to Market Street (bike lane on Octavia frontage road)

Item will be forwarded to SFMTA Board for approval and implementation after environmental clearance has been obtained.
