8. Townsend Corridor Improvement Project – Jonathan Streeter (Public Relations Officer)

- Project goal
 - Create a safer Townsend Street from 3rd to 8th streets
 - Improve safety for bikers
 - o Improve ped access to corridor
 - o Improve Muni reliability and connection to Caltrain
 - o Create safe, intuitive, and accessible loading zones for all users of the Caltrain station
- Over 70% of SF Caltrain riders walk, bike, or take transit to get to or from the train station
- Thousands of bike riders and peds cross near Caltrain station every day
- Construction Schedule
 - o Likely mostly during winter 2019 but could get pushed back depending on weather
- Largest concern with major Caltrain intersection is the stopping of ride hailing vehicles in bus stops or red curb areas
 - o SFMTA has no authority over ride hailing vehicles at this time
 - Only enforcement is through ticketing of drivers and prevention through education and geofencing
- Proactive ask to look at bike rack parking, especially for such large renovations such as in this project
