ORDER OF BUSINESS

1. Call to Order

Chair Borden called the meeting to order at 1:00 p.m.

David Pilpel shared that he did not have access to his computer and asked that if anything was found on the minutes, that the Board's approval allow for those corrections.

5. Communications

Chair Borden discussed the virtual meeting and expressed appreciation to staff for their work to enable the meeting to be held via teleconference. Board Secretary Silva reviewed how members of the public could watch the meeting and address the Board.

6. Introduction of New or Unfinished Business by Board Members

Director Yekutiel and Chair Borden commended staff for Outside Lands service.

Director Eaken acknowledged that she, Director Heminger and Director Lai attended the Geary Rapid Project Ribbon Cutting event and thanked staff.

PUBLIC COMMENT:

David Pilpel thanked Liz Brisson for her work.

Barry Taranto expressed concern over lack of taxi stands on Sunday at Outside Lands.

Director Tumlin recognized transit operator Sheldon Seymour and SFMTA Planning Director Sarah Jones. He also shared updates on Vision Zero, the vaccination mandate and service impacts, an award for the Presidio Bus Lift Project, and taxi medallions.

PUBLIC COMMENT:

David Pilpel shared that SFGovTV was streaming audio and not video, commented on Sarah Jones' departure, and expressed concern over the vaccination mandate and staff impacts.

Joe Kunzler expressed support for Director Tumlin and the vaccine mandate and also appreciated the high quality of Muni service.

Barry Taranto shared that SFGovTV was not functioning properly and expressed concern over purchased taxi medallions.

Aleta Dupree commented on vaccinations, expressing support for the safest Muni possible.

Michael Sachs expressed concern for free parking in San Francisco and questioned why San Francisco doesn't have congestion pricing in addition to more bike and bus lanes.

Dave Alexander recognized Sarah Jones for her work.

Anonymous thanked Sarah Jones for her work.

Mary Maguire expressed concern regarding taxi medallions and suggested that there be a mandate for taxi drivers to get vaccinated.

9. Public Comment

Members of the public may address the SFMTA Board of Directors on matters that are within the Board's jurisdiction and are not on today's calendar.

Aleta Dupree expressed transportation concerns, commented on long hauling, and the importance of inclusivity.

Herbert Weiner expressed concern about Geary Street and the impacts of discontinuing the express line, which allows riders to get to destinations much faster.

Barry Taranto commented on the Outside Lands festival, enforcement at the Chase Center, and payment changes for the essential worker ride home program.

Mary Maguire agreed with Barry Taranto's comment, expressed concern over a memo regarding the resumption of the full-time driving requirement, and asked the SFMTA to delay the deadline.

David Pilpel commented on the proposed Winter 2022 service plan, asked for a ramp at Church and 14th Street, and shared that he would follow up with staff on any further questions.

- C. ESTABLISH TOW-AWAY, NO PARKING ANYTIME Kimball Place, along south terminus, from east building line to 14 feet westerly.

Endorsing the City's 2021 Vision Zero Action Strategy, directing staff to move forward in four areas to advance Vision Zero that include: (1) developing, approving and implementing project proposals using the Quick Build toolkit for all remaining corridors on the City's High Injury Network by 2024; (2) exhausting the Quick Build toolkit within existing approval authority and to consider recommending tow-away zones and/or establishing new bike lanes as appropriate for expedited SFMTA Board approval; (3) advancing speed limit reductions for SFMTA Board consideration and approval as authorized by California Assembly Bill 43, including direction to bring a future item to the SFMTA Board to approve the specific corridors for speed limit reductions by ordinance, as required by the legislation; and (4) developing a comprehensive speed management plan to complement speed limit reductions with education campaigns and traffic calming; and directing SFMTA to conduct outreach and community engagement to inform design options and recommendations for Quick Build projects, but to move forward with robust safety improvements expeditiously, including parking and travel lane removal where appropriate. California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions</u>: Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
