- D. ESTABLISH TOW-AWAY NO STOPPING ANYTIME Pioche Street, north side of center median, from 25 feet east of Madison Street to 125 feet easterly; and Pioche Street, south side of center median, from Madison Street to 125 feet easterly.
- E. ESTABLISH BLUE ZONE 21 Buckingham Way, south side, from 0 feet to 20 feet east of truncated dome area of handicapped ramp (20-foot zone).
- F. REVOKE BLUE ZONE "50" Edward Street, north side, from 5 feet to 25 feet east of playground driveway (20-foot zone).
- G. ESTABLISH PART-TIME ACCESSIBLE PASSENGER LOADING ZONE, SUNRISE TO SUNSET, DAILY "50" Edward Street, north side, from 23 feet to 41 feet east of playground driveway (18-foot zone) (to correspond with new curb ramp).
- H. ESTABLISH BLUE ZONE "801" Moscow Street, east side, from 0 feet to 18 feet north of the south crosswalk (18-foot zone).
- I. EXTEND NO PARKING AT ANYTIME "20" Icehouse Alley, east side, from 0 feet to 17 feet south of north property line (17 foot zone).

WHEREAS, The public has been notified about the proposed modifications and has been given the opportunity to comment on those modifications through the public hearing process; now, therefore, be it

RESOLVED, That the San Francisco Municipal Transportation Agency Board of Directors, upon recommendation of the Director of Transportation approves the traffic modifications.
