Theodore Randolph stated that there should be a goal of decreasing VMTs (vehicle miles traveled) prior to proposed development are put into place.

Jennifer, from Sunnyside, commented on bus parking and how TNCs are congesting the street, the importance of getting data on who is driving in the evening, and the need to look at the frequency of evening buses, such as the #43 Masonic.

Chris Hanson expressed the importance of data in developing the TDM plan, including data from City College, including data focusing on people driving to City College in the evening. In addition, if students have difficulty parking then they are more likely not to attend school.
