#### **BRIEF DESCRIPTION:**

#### **PURPOSE**

Authorizing the Chief of the Bureau of Claims Investigation and Administration of the City Attorney's Office to settle unlitigated claims against the SFMTA for an amount not to exceed \$25,000.

#### **GOAL**

Goal 4: Financial capacity – to ensure financial stability and effective resource utilization.

#### DESCRIPTION

In November, 2009 the San Francisco Municipal Transportation Agency (SFMTA) Board of Directors adopted Resolution No. 09-191, which authorized the Chief of the Bureau of Claims Investigation and Administration of the City Attorney's Office to settle unlitigated claims not to exceed \$25,000 with the approval of the Director of Transportation.

In order to streamline government and improve efficiency of claims resolution, Director Reiskin recommends full delegation authority to settle unlitigated claims of less than \$25,000 to the City Attorney's Chief of the Bureau of Claims.

The Director of Transportation will continue to receive confidential monthly reports on all settlements under the delegated authority.

Currently the SFMTA Board of Directors approves all litigated settlements and unlitigated settlements over \$25,000.

## **ALTERNATIVES CONSIDERED**

The SFMTA Board could continue to require the Director of Transportation to approve the settlement of unlitigated claims in amounts between \$5000 and \$25,000.

WHEREAS, On November 3, 2009, the San Francisco Municipal Transportation Agency (SFMTA) Board of Directors adopted Resolution No. 09-191, which authorized the Chief of the Bureau of Claims Investigation and Administration of the City Attorney's Office ("Claims Chief") to settle unlitigated claims not to exceed \$25,000 with the approval of the Director of Transportation; and

WHEREAS, After approving such unlitigated claims for over six months, the Director of Transportation recommends full delegation of such claims to the Claims Chief; and

WHEREAS, Full delegation of such approval is authorized by law; and

WHEREAS, The SFMTA Board of Directors has determined that it is sufficient for the Claims Chief to settle unlitigated claims against the SFMTA in amounts not to exceed \$25,000 without concurrence of the Director of Transportation; and

WHEREAS, The City Attorney provides the Director of Transportation with confidential monthly reports on all settlements under delegated authority and will continue to do so; and

WHEREAS, This resolution will supersede the conflicting language of Resolution No. 09-191; now, therefore, be it

RESOLVED, That pursuant to Charter Section 6.102 and Article II of Chapter 10 of the San Francisco Administrative Code, the SFMTA Board of Directors authorizes the Chief of the Bureau of Claims Investigation and Administration of the City Attorney's Office to settle unlitigated claims against the SFMTA for an amount not to exceed \$25,000.
