**I acknowledge that in making this Color Scheme transfer, I will operate my medallion in compliance with the following stipulations:**

1. Found property will be turned in to the Color Scheme at the conclusion of each shift.
  2. All lease arrangements will be limited to a maximum of three layers (e.g. Owner/Color Scheme/Driver).
  3. The vehicle registration used for this taxicab will comply with the three-layer rule which contain at least a) my name, or b) that of the Color Scheme Holder, and c) may also contain the name of a driver holding a lease.
  4. I will not permit anyone to drive or operate the taxicab vehicle unless that person (a) holds a valid driver's permit issued by the SFMTA, (b) has a lease for the vehicle or is a gas and gate driver, (c) is listed on the driver's roster for the taxicab company with which I am associated, and (d) complies with all applicable driver training requirements established by the SFMTA and the SF Paratransit Broker.
  5. For Post-K medallion holders only. If I received my permit after 1978, I will comply with the 800 hours or 156 four-hour shift full-time driving requirement contained in the San Francisco Transportation Code Article 1100. SEC. 1109.
