This memo documents the following changes to Streets Division Directive Order #6501, issued March 7th, 2022. These changes better align these proposals with SFMTA's Curb Management Strategy.

 ESTABLISH – DUAL USE ZONE: METERED YELLOW ZONE, 6-WHEEL COMMERCIAL LOADING, 30-MINUTE TIME LIMIT, 8AM TO 5PM MONDAY THROUGH SATURDAY and WHITE ZONE, PASSENGER LOADING, 5PM TO 2AM DAILY 422 Hayes Street, north side, from 75 feet to 144 feet west of Gough Street, replacing metered stalls 410, 412, and 414 with one 35 foot metered stall and one 34 foot metered stall (69 foot zone)

Leaves the metered parking as-is.

2. ESTABLISH – DUAL USE ZONE: METERED YELLOW ZONE, COMMERCIAL LOADING, 30-MINUTE TIME LIMIT, 7AM TO 6PM MONDAY THROUGH SATURDAY, PASSENGER LOADING GENERAL LOADING ZONE, ALL OTHER TIMES

580 Hayes Street, north side, from 53 feet to 119 feet east of Laguna Street, at metered stalls 530, 532, and 534 (66-foot zone)

Replaces passenger loading with a general loading zone.
