#### **DIVISION:** Human Resources

#### **BRIEF DESCRIPTION:**

Authorizing the Director of Transportation to approve amendments to two As-Needed Specialized Training Services contracts: (1) Amendment No. 6 to Contract No. SFMTA-18-39-A with Moran Consulting, Inc. to extend the contract duration 15 months beyond the contract's 5-year term, and to increase the contract amount by \$1,000,000 from a not-to-exceed amount of \$3,821,598.22 to a notto-exceed amount of \$4,821,598.22; and (2) Amendment No. 3 to Contract No. SFMTA-18-39-B with DTUI.com LLC to extend the contract duration 15 months beyond the contract's 5-year term without increasing the not-to-exceed amount of \$3,000,000.

#### **SUMMARY:**

- To better prepare our workforce for roles that require public interaction, in January 2019 the • SFMTA awarded As-Needed Specialized Training Services contracts to Moran Consulting and DTUI.com to create customized training programs that train employees to provide improved customer interactions, reduce customer conflicts, and mitigate assaults.
- The contracts provide de-escalation, customer service, racial equity, augmented implicit bias, • conflict intervention, team-building, management, supervisor, and employee support training for managers, supervisors and public-facing team members to mitigate assaults on employees, labor grievances, potential EEO complaints, and enhance employee culture.
- The two contracts are scheduled to expire on January 16, 2024. The proposed amendments ٠ would extend both contracts for 15 additional months (one-fourth of the original contract term, including options, of five years) to April 16, 2025.
- The amendment to the Moran contract would also increase the contract not to exceed amount • by \$1,000,000 or 26,17 percent from, \$3,821,598.22 to \$4,821,598.22.
- The proposed additional time and funding would allow time to permit the SFMTA to conduct • a competitive reprocurement allowing the work to continue until new contracts are awarded.

## PURPOSE

Authorizing the Director of Transportation to approve amendments to two As-Needed Specialized Training Services contracts: (1) Amendment No. 6 to Contract No. SFMTA-18-39-A with Moran Consulting, Inc. to extend the contract duration 15 months beyond the contract's 5-year term, and to increase the contract amount by \$1,000,000 from a not-to-exceed amount of \$3,821,598.22 to a not-to-exceed amount of \$4,821,598.22; and (2) Amendment No. 3 to Contract No. SFMTA-18-39-B with DTUI.com LLC to extend the contract duration 15 months beyond the contract's 5-year term without increasing the not-to-exceed amount of \$3,000,000.

## STRATEGIC PLAN GOALS AND TRANSIT FIRST POLICY PRINCIPLES:

This action supports the following SFMTA Strategic Plan Goals:

1. Identify and reduce disproportionate outcomes and resolve past harm towards marginalized communities.

- 2. Create a work environment that is responsive, equitable and inclusive.
- 3. Recruit, hire and invest in a diverse workforce.
- 4. Make streets safer for everyone.
- 5. Deliver reliable and equitable transportation services.
- 7. Build stronger relationships with stakeholders.

This action supports the following Transit First Policy Principles:

To ensure quality of life and economic health in San Francisco, the primary objective of the transportation system must be the safe and efficient movement of people and goods.
The City and County shall encourage innovative solutions to meet public transportation needs wherever possible and where the provision of such service will not adversely affect the service provided by the Municipal Railway.

#### DESCRIPTION

Transportation is a high-pressure industry. Because the SFMTA manages all aspects of transportation in the City and County of San Francisco, the vast majority of employees are in challenging, customer-facing roles such as operating public transit vehicles on congested streets, writing parking citations and conducting transit fare inspections. The SFMTA requires ongoing and continuous training services to those who often interact with the public or those who supervise public-facing employees.

Since January 2019, the as-needed specialized training contracts with Moran Consulting and DTUI have facilitated the development and management of the Practical Communication Tools (PaCT) training programs for our public-facing workforce in the areas of de-escalation, customer service, emotional intelligence, and recovery strategies. The contractors work to improve employee support, team member engagement, and overall employee wellness threads to our outreach and recruitment strategies.

In that time, the contracts' specialized training consultants have completed:

- A comprehensive assessment of training needs
- Staffing of working groups and training managers from all 10 SFMTA units to partner with Contractor Moran to design training program and tools
- The test of a Pilot program for Transit and Sustainable Streets
- Program refinement and implementation strategyA plan for delivery of training in-person, on site, and on shift to minimize the need for overtime
- Development of a co-facilitator model that incorporates subject matter experts into the training room and into the facilitation process, to create trust in the training's subjects and methods.
- Formally introduction of the Universal Standards for Service
- Service Essentials for Leaders training: 10 training sessions, 53 Managers, Approximately 424 personnel training hours
- PaCT training: 293 training sessions, 2,046 employees, Approximately 16,368 personnel training hours

The contract extensions are needed to continue the positive results of the training efforts while a followon contract is competitively procured. The process of developing and implementing the training has shown that the training effort does improve emotional, communication, and operational safety in the general public and internally within the SFMTA's own teams. Extending the existing contracts will ensure that the Agency continues those improvements by not interrupting its provision of training resources for team members, supervisors, and managers of public facing teams.

During the contract extensions, the Contractors will be expected to continue to work with the Organizational Development/Learning & Organizational Development teams to develop training programs to: 1) Create a culture of outstanding service by providing customized training programs to customer-facing employees and those who supervise them; 2) set up a framework to institutionalize customer engagement skills, including de-escalation techniques training as a standard business practice; and 3) Build internal awareness and skills for managing implicit bias in the workplace and when working with the public. An extended gap in providing those training programs would threaten the gains that have been made over the past five years.

## STAKEHOLDER ENGAGEMENT

This extension of funding and time is to allow continuation of already-approved contract activities, so no new stakeholder engagement was sought on the specific decision to extend the contracts. Nevertheless, stakeholders continue to supply feedback that supports for expanded and continuous training in the areas covered by the Contracts.

## ALTERNATIVES CONSIDERED

The alternatives considered to meet program needs were: (1) to provide services in-house; (2) to reprocure without extension; or (3) to reprocure while continuing to provide the services under extensions to existing contracts.

Current staff do not have sufficient time available or the range of specialized expertise necessary to complete all contracted work, and new staff cannot be hired to provide services in-house accomplish many of the current and immediate needs of the organization. In addition, due to the amount of time a

hiring process takes, the current contracts would expire, and the program would have a lapse of service before new staff could hired.

A rebidding process is being initiated but cannot be completed before the current contract end date of January 2024, resulting in a lapse of vital program services that could further increase the potential for operator assaults, lack of operational communication, grievances, labor, and EEO complaints.

For these reasons, staff considers that extending the existing contracts by 15 months is the best way to preserve the gains made so far and avoid additional costs of restarting the program after a lapse.

## FUNDING IMPACT

The proposed resolution amends two contracts: one contract with Moran Consulting, Inc. and one contract with DTUI.com LLC. Both contracts are as-needed contracts, which means services are used as needed, up to the not-to-exceed value of the contract. Both contracts are funded by the operating budget.

The proposed amendment to the contract with Moran Consulting, Inc would increase the contract notto-exceed to exceed amount by \$1,000,000 or 26.17 percent from, \$3,821,598,22 to \$4,821,598.22. As of October 30, 2023 approximately \$3,779,311.88 or 99 percent of the existing contract amount had been expended. The proposed amendment to the contract with DTUI.com LLC maintains the existing contract not-to-exceed amount of \$3,000,000 or which \$817,500 or 17 percent has been expended.

#### **ENVIRONMENTAL REVIEW**

On October 19, 2023, the SFMTA, under authority delegated by the Planning Department, determined that the contract amendments for specialized training with DTUI.com and Moran Consulting, Inc., are not a "project" under the California Environmental Quality Act (CEQA) pursuant to Title 14 of the California Code of Regulations Sections 15060(c) and 15378(b).

A copy of the CEQA determination is on file with the Secretary to the SFMTA Board of Directors and is incorporated herein by reference.

## OTHER APPROVALS RECEIVED OR STILL REQUIRED

The City Attorney has reviewed this report.
