BACKGROUND INFORMATION / COMMENTS This proposal to replace time-limited RPP with metered parking is in response to the construction of a new SFSU Academic building, which previously was occupied by a residential building. This proposal therefore will improve consistency in curb regulations with adjacent blocks and respond to the change in land use with the opening of the new Academic building on the fronting blocks. This proposal will yield approximately 10 metered spaces along Font Blvd, approximately 4 metered spaces along Holloway Ave, approximately 10 metered spaces along the West side of Tapia Drive, and approximately 13 spaces along the South Side of Tapia Drive.
