AMENDMENT TO ESTABLISH GREEN ZONE ON NORTHSIDE GROVE STREET

- Permit parking space to be removed on the north side of Grove Street, 114 feet to 122 feet west of Dr. Carlton B. Goodlett Place, permit stall #75.
- TC 801:
 - Existing: (21)(A)(i) restricts parking to permit holders, "Grove Street, north side, between Van Ness Avenue and Polk Street (360-foot zone, accommodating 25 angled parking stalls)."
