CAC Motion 250501.01

The SFMTA CAC recommends that the SFMTA reject any attempt to increase congestion, worsen Muni service, and undermine safety on Lower and Mid-Market by adding commercial passenger vehicles, including Waymo robotaxis, to this critical section of the public right of way. We reject any justification for this change grounded in "helping the downtown recovery" as unfounded, and believe that degraded Muni service will, instead, slow the economic recovery effort. Finally, we express our concern that prioritizing Waymo customers over Muni riders caters to the affluent rather than investing in public services used by all San Franciscans.
