## **April Meeting Recap**

### **April 23rd Meeting Minutes**

#### **Bayview Shuttle grant update:**

- The project was on track to not expend the full grant amount by the end of the current grant end date (March 31, 2026)
- Work with community to identify projects that can utilize project funds

#### Shuttle service proposals:

- Reviewed a proposal to extend the service area north to Cesar Chavez St. (includes Rafiki Coalition)
- Shared four options to extend shuttle operating hours
- Community Congress delegates preferred a mixture of options
- May 2025 meeting delegates approved of service area extension and new operating hours proposals

#### Call for new members:


 Officially removed inactive CC delegates and announced we would begin recruitment for new delegates in July 2025





### **New Delegate Recruitment**

### Eligibility:

Must live, work, or worship in D10, or have historical ties to the area.

### Responsibilities:

Attend regular meetings, special meetings, and committee meetings.

Abide by the Congress's Code of Conduct and Conflict of Interest Policy at meetings and in their work for the Congress.

## **Community Congress Bylaws**



#### Article II Section 4

Congress members can be removed for 3 unexcused absences or misconduct, upon:

- Formal notice
- Placement of the issue on a Community Congress meeting agenda
- Vote of the Congress

Congress members shall give 5 business days notice for resignation, except for resignations forced by personal emergencies.

#### **Article III Section 4**

Public notice of Congress meetings shall be posted a week before regular meetings

#### **Article III Section 7**

Absolute (simple) majority of the membership of the Congress is required for a quorum.

#### **Article III Section 8**

Congress will conduct an absolute (simple) majority vote for Congress decisions in person and/or via email.

# California Air Resources Board (STEP) Grant Amendment





### **CARB Amendment**

- Extends operations of the shuttle until November 30, 2027!
- Continues the following tasks with no scope changes
  - Shuttle operations
  - Transportation Resource Center and staffing
  - Quarterly Community Congress meetings
  - CBTP street safety project implementation
- Restructures the workforce development component





# **Workforce Development**

### **Continue:**

- Recruiting, training, and hiring local residents as part of the service
- Building a pipeline to the CityDrive program for residents to become Muni operators





# **Proposal #1**

 Require the shuttle operator to subcontract with an incommunity repair shop to complete all repairs and maintenance work

 Coordinate quarterly trainings with the repair shop that are open to the public to develop skills in maintenance and repairs





# **Proposal #2**

- Establish a "Barriers to Access" fund that will provide financial assistance to community residents for work or job-related expenses
- Determine eligibility requirements and eligible costs






# **Proposal #3**

- Youth-led community histories project featuring community tours using the shuttle
- Interns hired on a quarterly basis will plan and promote tours that highlight different community assets
